	1. The volume of trap dewar should be 180 liters	
	 There should be a vacuum space between inner and outer jacket of dewar. The line pressure should handle ≥ 50 psi. 	
	 Material of the tank should be made of SS 304. 	
	5. The dewar should be supported by heavy duty castor wheels.	
	6. There should be safety relief valve, drain port, vacuum port in dewar with appropriate valves.	
	Two Coils should be made of copper, one will go inside the dewar (neck diameter should be adjusted accordingly) and one remain outside.
