## ANNEXURE-I

### TECHNICAL SPECIFICATION FOR THE SAFETY CABINETS FOR CYLINDERS:

- a) Capacity: The cabinet should have sufficient space (approximate dimension (LxBxH= 62"x40"x74") to accommodate 12 cylinders (47L water capacity, 9.25" diameter , 60" height each).
- b) Door should be equipped with lock and key. Door style -hinged doors, outside swing
- c) Material: aluminium (non-corrosive).
- d) Cabinet is intended for the storage of the cylinders as well as to operate from inside. Safety clamps to attach the cylinder to wall of the cage should be there. Sufficient space above each cylinder (LxBxH=13"x12"x13.5") to use pressure regulators and to connect gas tubings should be there.
