	The seat shall be made of 15mm thick hot pressed commercial plywood upholstered with high resilience polyurethane foam 30mm thick having density 32kg/m³ with leatherite tapestry 0.8mm thick and 535 GSM and the back shall be made of metal insert pipe upholstered with high resiliance polyurethane foam 25mm thick having density 32kg/m³ with leatherite tapestry 0.8mm thick and 535 GSM. The chair shall have 3600 revolving mechanism. The pneumatic seat height adjustment for healthy seating, user can adjust seat height upto 150mm with BIFMA standard class-3 gas-lift to suit them using the lever under the seat.
