The eligibility criteria (for Envelope A) for undertaking the work will be as follows:

- 1. Proof of having valid enlistment /completion with Central/State Government, Autonomous Body,
- 2. The agency must have executed supply of similar consumables directly during last seven years ending March 2019 as:

(a) Three similar supply each of value not less than 40% i.e. Rs.2.34 lakh

OR

(b). Two similar supply each of value not less than 50% i.e. Rs. 2.93 Lakh

OR

(c). One similar supply having value not less than 80% i.e. Rs. 4.68 Lakh.

Out of which one should be in Govt./Central PSU's/ Autonomous body/ . Similar supply means "consumables related to DG sets".

- 3. The Agency should also submit a copy of the partnership deed if any and power of attorney duly Attested and countersigned by the agency at the time of application.

Eligibility related documents shall be evaluated for criteria stipulated at Envelope A of General Conditions and Consultants will accordingly be qualified/disqualified by the Competent Authority. The financial bid (Envelope No2) of qualified quotationer shall then be opened by the committee at notified time, date. The rates of each items must be quoted in figures and words. Quotation not submitted in the manner as prescribed above shall summarily be rejected.

### TERMS AND CONDITIONS FOR PERIODIC SERVICE OF DG SETS& FIRE PUMPS

### FOR THE CONTRACTOR:

1. The parts supplied should be genuine and original of the respective OEM of DG sets as mentioned in BOQ. If any part is found fake/duplicate, entire lot would be rejected.

2. Fitment of parts/consumables is IISER's responsibility. However, if because of any reason any part fails to fit in the respective slot, the same part has to be got replaced by the vendor.

3. Minimum 1 year warranty required on all parts.

4. If there occurs any damage to the DG set because of fake or duplicate parts, then entire responsibility would be of the contractor and appropriate action would be taken against him in this regard.

### **PAYMENT**

Payment after servicing on pro-rata basis for each quarter.

#### **OTHERS CONDITIONS OF THE RFQ**

- 1. The rates shall be quoted in the enclosed schedule of quantities and duly signed by the contractor.
- 2. Rates to be basic but inclusive of GST.
- 3. Rates to remain firm during the duration of work as well as for the extended period, if any. No escalation in rates will be allowed in any circumstances.

### **Instructions for Online Bid Submission:**

The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal.

More information useful for submitting online bids on the CPP Portal may be obtained at: <u>https://eprocure.gov.in/eprocure/app.</u>

### REGISTRATION

- 1) Bidders are required to enroll en the e-Procurement module of the Central Public Procurement (<u>https://eprocure.gov.in/eprocure/app</u>) by clicking on the link "Online bidder: Enrollment" on the CPP Portal which is free ofcharge.
- 2) As part of the enrolment process, the bidders will be required to choose a unique usernameas assign a password for their accounts.
- 3) Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPPPortal.
- 4) Upon enrolment, the bidders will be required to register their valid Digital SignatureCertificate (Class II or Class III Certificates with Signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify /nCode /eMudhra etc.), with theirprofile.
- 5) Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC's to others which may lead tomisuse.
- 6) Bidder then logs in to the site through the secured log-in by entering their user ID /password and the password of the DSC/e-Token.

#### SEARCH FOR TENDER DOCUMENTS

- There are various search option built in the CPP Portal, to facilitate bidders to search active tenders by several parameters. These parameters could include Tender ID, Organization Name, Location, Date, Value, etc. There is also an option of advanced search for tenders, wherein the bidders may combine a number of search parameters such as Organization Name, Form of Contract, Location, Date, Other keywords etc. to search for a tender published on the CPP Portal.
- Once the bidders having selected the tenders they are interested in, they may download the required documents / tender schedules. The tenders can be moved to the respective 'My Tenders' folder. This would enable the CPP Portal to intimate the bidders through SMS / email in case there is any corrigendum issued to the tenderdocument.
- 2) The bidder should make a note of the unique Tender ID assigned to each tender, in case they want to obtain any clarification I help from theHelpdesk.

#### **PREPARATION OF BIDS**

- 1) Bidder should take into account any corrigendum published on the tender document before submitting theirbids.
- 2) Please go through the tender advertisement and the tender document carefullyto understand the documents required to be submitted as part of the bid. Please note the number of covers in which the bid documents have to be submitted, the number of documents - including the names and content of each of the document that need to be submitted. Any deviations horn these may be to rejection of the bid.
- 3) Bidder, in advance, should get ready the bid documents to be' submitted as indicated in the tender document / schedule and generally, they can be in PDF / XLS / RAR / DWF / JPG formats. Bid documents may be scanned with 100 dpi with black and white option whichhelps in reducing size of the scanneddocument.
- 4) To avoid the time and effort required in uploading the same set of standard documents which are required to be submitted as a part of every bid, a provision of uploading such standard documents (e.g. PAN card copy, annual reports, auditor certificates etc.) has been provided to the bidders. Bidders can use "My Space" or {father Important Documents' area available to them to upload such documents. These documents may bedirectly submitted from the "My Space" area while submitting (;I bid, and need not be uploaded again and again. This will lead to a reduction in the time required for bid submission process.

#### SUBMISSION OF BIDS

- 1. Bidder should log into the site well in advance for bid submission so that they can upload the bid in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other issues.
- 2 The bidder has to digitally sign and upload the required bid documents one by erne asindicated in the tenderdocument.
- 3 Bidder has to select the payment option as "offline" to pay the tender fee / EMD asapplicable and enter details of theinstrument,
- 4 Bidder should prepare the EMD as per the instructions specified in the tender document. The original should be posted/couriered/given in person to the concerned official, latest by the last date of bid submission or as specified in the tender documents. The details of the DO/any other acceptedinstrument, physicallysent *r*should tally with the details available in the scanned copy and the data entered during bid submission time. Otherwise the uploaded bid will be rejected.
- 5. Bidders are requested to note that they should necessarily submit their financial bids in the format provided and no other format is acceptable. If the price bid has been given as a standard BOQ format with the tender document, then the same is to be downloaded and to be filled byall the bidders. Bidders are required to download the BOQ file, open it and complete the white colored (unprotected) cells with their respective financial quotesand other details (such as name of the bidder). No other cells should be changed. Once the details have been completed, the bidder should save it and submit it online, without changing the filename. If the BOQ file is found to be modified by the bidder, the bid will be rejected.
- 6. The server time (which is displayed on the bidders' dashboard) will be considered as the standard time for referencing the deadlines for submission of the bids by the bidders, openingof bids etc. The bidders should follow this time during bidsubmission.

- 7. All the documents being submitted by the bidders would be encrypted using PKI encryption techniques to ensure the secrecy of the data. The data entered cannot be viewed by unauthorized persons until the time of bid opening. The confidentiality of the bids is maintained using the secured Socket Layer 128 bit encryption technology. Data storage encryption of sensitive fields is done. Any bid document that is uploaded to the server is subjected to symmetric encryption using a system generated symmetric key. Further this key is subjected to asymmetric encryption using buyers/bid openers public keys. Overall, the uploaded tender documents become readable only after the tender opening by the authorized bidopeners.
- 8. The uploaded tender documents become readable only after the tender opening bythe authorized bidopeners.
- 9. Upon the successful and timely submission of bids (i.e after Clicking "Freeze Bid Submission" in the portal), the portal will give a successful bid submission message & a bid summary will be displayed with the bid no. and the date & time of submission of the bid with all other relevant details.
- 10. The bid summary has to be printed and kept as an acknowledgement of the submission of the bid. This acknowledgement may be used as an entry pass for any bid openingmeetings.
