1.1 The INSTITUTE shall consider SERVICE CONTRACT of laundry services for those bidders whose offers have been found technically, commercially and financially acceptable. The INSTITUTE reserves the right to counter offer price(s) against price(s) quoted by any bidder.

2. PERFORMANCE BANK GUARANTEE & EXECUTION OF CONTRACT:

2.1 Firm whose offer is accepted will have to furnish Performance Bank Guarantee/FDR of an amount of Rs. 5000/- in favour of REGISTRAR IISER MOHALI issued by any scheduled bank.

2.2 The performance Bank Guarantee submitted/FDR should be valid for Contract period plus three months.

2.3 The Performance Bank Guarantee/FDR shall be refunded within 90 days after completion of the contract as per order, or after the expiry of contract on satisfactory completion of the same whichever is later.

2.4 No interest will be paid on Performance Bank Guarantee.

2.5 In case of breach of any terms and conditions of the contract or on unsatisfactory performance, the amount of security deposit shall be liable forfeited by DIRECTOR IISER MOHALI and his decision shall be final.

2.6 The expenses of completing and stamping the agreement shall be paid by the bidder.

SUBMISSION OF TENDER

I. All bid/ tender documents are to be uploaded online at Central Public Procurement

portal i.e. <https://eprocure.gov.in/eprocure/app> only and in the designated cover/ part on the website against tender ID. Tenders/ bids shall be accepted only through online mode and no manual submission of the same shall be entertained except tender fee and EMD. Late tenders will not be accepted.

- II. The online bids shall be opened at the office of the Assistant Registrar (P&S), IISER Mohali, on above given date and time. If the tender opening date happens to be on a holiday or non-working day due to any other valid reason, the tender opening process will be attended on the next working day at same time and place. IISER Mohali will not be responsible for any error like missing of schedule data while downloading by the Bidder.
- III. The bidder shall upload the tender documents duly filled in and stamped by the authorized signatory on each and every page. Tender not submitted/uploaded in the prescribed form and as per the tender terms and conditions shall be liable for rejection.
- IV. The bidder shall upload scanned copy of the PAN Card, GST number duly signed and stamped. **Also bidders applying against ‘MSME/NSIC Certificate’ issued by appropriate Authority, should ensure that the certificate attached is relevant to the area of service/supply.
