- 1. Quotations must be submitted in two bid system i.e, technical and commercial, otherwise, their bid will be rejected.
- 2. Agency must have executed at least one similar work (cleaning of underground water tanks) valuing 80% (1,01,160/-) directly in any Govt/ Autonomous/PSU department / organization.
- 3. Valid PAN/GST number
- 4. The rates shall be quoted in the enclosed schedule of quantities and duly signed by the contractor.
- 5. Work to be carried out strictly as per the specifications.
- 6. Rates to remain firm during the duration of work as well as for the extended period, if any. No escalation in rates will be allowed in any circumstances.
