	TECHNICAL SPECIFICATIONS:		
	a) System should be of 400-500 Liters capacity and should have clear and legible LED display with advanced Interface conveniently located at eye level.		
	b) System should have a fully programmable microprocessor controlled with membrane keypad and eye level control panel.		
	c) System should have an Automated vent port for quick re-access to samples as part of the eye level display / advanced interface		
	d) Compressor fan air filter conveniently located on the front panel for ease of access for cleaning and maintenance.		
	e) System should have Dedicated alarm and backup system for 24/7 sample safety		
	f) System should have Programmable operating temperature from -50 °C up to -86°C with 1°C increment at 32 °C Maximum ambient operating temperature.		
	g) System should be highly energy efficient, with energy consumption around or less than 9 KWh/day when freezer is at -80 $^{\circ}$ C		
	h) Insulation should be of high-quality material (e.g., PolyUrethane Foam (PUF)) to maintain highest heat insulation.

	j) At least 5 inner doors should have tight sealing to prevent temperature loss and Outer door should have reinforced tight sealing.

	m) System should have in-built security keyed locks and with option to lock the ergonomically designed door handle with a padlock; third party padlock should not be supplied with the system.

	p) Freezer must have battery back-up and password protection security to avoid unauthorized tampering of freezer settings.

	r) System must have audible and visible alarms for temperature, power failure, system failure, low battery etc.		

- s) Freezer must have HFC-free, CFC-FREE, HCFC-FREE non-flammable refrigerants, and should have Green Natural HC Gas based refrigeration system.
- t) It must be energy efficient and hermetically sealed two stage cascade refrigeration system.
- u) Freezer must have ISO 9001 standard quality test requirements and IEC 61010 Electrical safety CE certified.
- v) Freezer should have capacity to hold at least 20 racks and more than 31000 samples of 2" height vials
- w) Freezer should be supplied with at least Hindalium anodised 6 racks.
- x) 5KVA Voltage Stabilizer (e.g., Servo technology based) should be supplied along with the instrument. Indian electric connection compatible plug should be provided.
- y) Freezer should have at least two years warranty. Particularly, at least 5-years warranty on compressors and refrigerant should be clearly mentioned.
- z) The supplier should provide free maintenance services during the warranty period. These include Preventive & Routine Maintenance and Breakdown and corrective maintenance.

- II. Restriction under Rule 144 (xi) of the General Financial Rules (GFRs). 2017 under sub clause 3, in terms of DOE, MoF No. F.18/37/2020-PPD dated: 8th February, 2021:

- (i) A bidder is permitted to procure raw material, components, sub-assemblies etc. from the vendors from countries which shares a land border with India. Such vendors will not be required to be registered with the Competent Authority, as it is not regarded as "sub-contracting".
- (ii) However, in case a bidder has proposed to supply finished goods procured directly/indirectly form the vendors from the countries sharing land border with India, such vendor will be required to be registered with the Competent Authority.
- III. The online updated Price BOO is in INR format. Bids are invited in INR only against domestic tender.
- IV. The Online bids should be submitted directly by the original manufacturer/supplier. If quotation is submitted/filled by any representative/agent/dealer then they must upload a authority certificate from the principal company.
- V. <u>All MSME/NSIC/Startup Units shall be considered as per provisions/rules prescribed by Govt of India.</u>

- VII. Warranty: Minimum one year, if not mentioned above.

B) SUBMISSION OF TENDER

- I. All bid/ tender documents are to be uploaded online at Central Public Procurement portal i.e. https://eprocure.gov.in/eprocure/app only and in the designated cover/ part on the website against tender ID. Tenders/ bids shall be accepted only through online mode and no manual submission of the same shall be entertained except tender fee and Annexure I (Bid Securing Declaration Form). Late tenders will not be accepted.
- II. The online bids shall be opened at the office of the Assistant Registrar (S&P), IISER Mohali, on above given date and time. If the tender opening date happens to be on a holiday or non-working day due to any other valid reason, the tender opening process will be attended on the next working day at same time and place. IISER Mohali will not be responsible for any error like missing of schedule data while downloading by the Bidder.
- III. The bidder shall upload the tender documents duly filled in and stamped by the authorized signatory on each and every page along with all necessary Annexures as per NIT. Tender not submitted/uploaded in the prescribed form and as per the tender terms and conditions shall be liable for rejection.
- IV. The bidder shall upload scanned copy of the PAN Card, GST number duly signed and stamped. Also bidders applying against "MSME/NSIC Certificate" issued by appropriate Authority, should ensure that the certificate attached is relevant to the area of service/supply. C) INSTRUCTIONS

1. The Online bids should be submitted directly by the original manufacturer/supplier, If quotation is submitted/filled by any representative/agent/dealer then they must upload a authority certificate from the principal company for quoting the price otherwise such

- quotation will be rejected.
- 2. The quantity mentioned in this inquiry is and shall be deemed to be only approximate and will not in any manner be binding on the Institute. Before the deadline for submission of the online bid, IISER Mohali reserves the right to modify the tender document terms and conditions. Such amendment/modification will be notified on website against said tender ID.
- 3. The rates offered should be FOR Chandigarh/Mohali in case of firms situated outside Chandigarh/Mohali, and free delivery at the Institute premises in case of local firms. Conditional tenders will be summarily rejected.
- 4. In case of Ex-godown terms the amount of packaging forwarding freight etc. should clearly be indicated by percentage or lump sum amount. Institute has policy not to make any advance payments towards any purchase, Letter of credit can be opened if required.
- 5. THE INSTITUTE IS EXEMPTED FROM CUSTOM DUTY under notification no-TU/V/RG-CDE(1062)/2016 CUSTOM DT. 12.10.2018.
- 6. Tax: This Institute is not exempted from the payment of GST. The current rate (i.e. percentage of GST should be clearly indicated included or excluded) wherever chargeable. Please also provide/upload the copy of PAN card, GST number duly self-attested.
