The in-built compressor should be insulated in the compressor compartment to minimize the noise in the lab. As the nitrogen generator must work within the main lab (to be installed in the Mass analysis lab) and the noise level should not be more than 57dB. The in-built compressor is a must. 24 h gas supply is a must. № 2 gas purity range 99.5-99.99%. Dry nitrogen (dew point) range = -30 °C. The nitrogen generator should be compatible with the Waters HDMS (Waters Synapt G2-Si) machine. The system must come with visual alarms to avoid unexpected breakdowns. The generator must have an inbuilt power saver mode to save the continuous operations of the gas generator to save the generator life. Hydrocarbon content should be < 1 ppm in order to save hydrocarbon-free nitrogen in LCMS operations. The company must have dedicated engineers for gas generators & proven service record to support the critical application. Sufficient consumable & spare stock should be available at the local regional office to support timely service. The generator must have a compact size to even fit under a standard lab bench to save lab space and should have wheels for necessary movement in the lab.
