## **Instructions, Terms & conditions:-**

1. The Scrap Material is offered for disposal on “**AS IS WHERE IS**”. GST/Taxes and duties if any applicable by Government (State Govt/Central Govt/Local Municipality) shall be met by the buyer.
2. The bidder may inspect the above Scrap Material on any working day from 16.11.2022 to 30.11.2022 between 11 AM to 4 PM with prior approval from Purchase Section/IWD. No Complaint whatsoever will be entertained after closing of e-tender. No request for inspection after submission of e-tender will be accepted.
3. All auction will be made strictly on “As is where is” basis. Once the bid is accepted, no claim will be entertained with regard to quantity, quality, measurements, sizes, models, numbers and weights etc.
4. The Director, IISER-Mohali reserves the right to accept/reject any bids or to add /delete any lot(s) put to Auction without assigning any reasons therefor. In case of any dispute, the Director, IISER-Mohali will be the sole Arbitrator and his decision will be final & binding.
5. The offers given in the valid tenders received through online mode within due date and time and accompanied with the required amount of Tender Fee and Security Deposit only will be considered.
6. EMD: Bidders are required to furnish bid security undertaking (**Annexure-I**) in lieu of EMD in terms of MoF, DoE Order No. F.9/4/2020-PPD dated 12.11.2020.
7. In the event of acceptance of tender, the successful bidder be required to deposit full amount in shape of Demand Draft/Pay order/ Online in favour of The Registrar IISER Mohali within 7 days from the issue of order, failing which the sale order shall be cancelled and **Security Deposit** will be forfeited.
8. For old and used Transformer/Lubricating Oil and Batteries-Only such units who are actual users and are registered with the M.O.E.F, New Delhi shall be considered for E-Tender cum Auction. The bidders have to attach scan copy with online bid.
  - a) Registration Certificate issued by M.O.E.F, New Delhi as Recycler/reprocessor of hazardous wastes etc.
  - b) Consent under water and air acts and authorization under hazardous wastes (Management & handling) rules-1989 and amendments thereof from the respective State Pollution Control Boards.
  - c) The bidder shall produce the log book duly endorsed by the previous sellers for the quantity of oil purchased till date.
  - d) Quantity of recyclable waste shall not exceed the prescribed limit as per certificate issued by the M.O.E.F, New Delhi.
  - e) Bidder has to produce the original and one attested copy from Notary Public of the following documents at the time of lifting of material. These documents shall be checked by the Institute at the time of lifting the material.
9. **E-Waste: Bidders must have E-Waste valid license for recycling of E-Waste materials and products. The list of E-Waste items are placed as Annexure IV.**

10. The materials/as per lot will be allowed to carry only after the receipt of full payment and has to be lifted at their own expenses within 07 days of completion of deal failing which ground rent at the rate of Rs. 500/- per day will be charged. No assistance/transportation will be provided by IISER Mohali. Permission to take out the disposed scarp material from IISER Mohali premises will not be allowed on holidays, Saturdays and Sundays etc.
11. The person authorized by bidder will be allowed to take the delivery. The bidder is required to produce any document as evidence for proof of their address. (AADHAR/ PAN Card/ Voters Identity Card/Driving License in case of individual and Registration Certificate in case of firms etc.)
12. **Security Deposit** of the bidder rescinding their offer, withdrawing or abrogating after submitting the bid shall stand forfeited. Decision of IISER Mohali shall be final in this regard.
13. **Security Deposit** of unsuccessful bidders shall be returned within three weeks of the award of contract to successful party.
14. The bidder is required to reveal his full name/name of the authorized signatory of the firm/name of father, full postal address, telephone number & mobile number, PAN Number/Aadhar Number/GST Number.

18. Bidder shall alone be responsible for furnishing any false or wrong information and the consequences or loss thereof.
19. The address given in the tender shall be deemed to be bidders address and correspondence on that address shall be considered to have been delivered to the bidder. No claim will be entertained for the reason of forfeiture of the sum deposited in case the correspondence is received back undelivered.
20. Once the release order issued, this office will not be responsible either for safe custody or for any loss or damage to the subject Scrap Material.
21. In case the bidder is a company, the name of the company should be indicated as the bidder. In such cases the person appearing for the company should have the authorization letter in a proper format issued from a competent authority of the company.
