#### 2. Generic

### 3. Generic

### 15. Warranty

The seller should guarantee the rectification of goods in case of any break down during the guarantee period. ## 16. Warranty

Timely Servicing / rectification of defects during warranty period: After having been notified of the defects / service requirement during warranty period, Seller has to complete the required Service / Rectification within 5 days time limit.
