The Instrument: The required atomic absorption spectrophotometer (AAS) should be fully automated with PC controlled double beam instrument with capabilities of Atomic Absorption and Flame Emission measurements of many elements with deuterium and self-reversal background correction. Future upgradability with integrated graphite furnace from the same manufacturer should be there. The quoted instrument should also be upgradable with an auto-sampler unit from the same manufacturer in future. The quoted instrument should also be capable of working with a hydride generator from the same manufacturer.	
	2. Optics: True Double Beam, Sealed & Vibration free optical System with a reflective optical compartment.	
	3. Monochromator: Czerny-Turner type with Holographic Grating of 4500 lines/mm (or better) and Reciprocal Linear Dispersion better than 0.448 nm/mm, focal length 330mm.

- II. Restriction under Rule 144 (xi) of the General Financial Rules (GFRs). 2017 under sub clause 3, in terms of DOE, MoF No. F.18/37/2020-PPD dated: 8th February, 2021:
