A) IMPORTANT NOTES:-

- I. The online updated Price BOQ is in INR format. If bidder want to quote other than INR please specify the quoted currency in the Technical Bid/Part and fill the amount in same updated BOQ.

External PC controlled Benchtop EPR Spectrometer with essential software should be able to study the free radicals, transition metal complexes etc. in liquid as well as solid samples at room and liquid nitrogen temperatures.

Requirements

- 1. Should be able to study the free radicals, transition metal complexes Cu(II), Mn(II), Fe(III) complexes etc. in liquid as well as solid samples at room and liquid nitrogen temperatures (77K) and all accessories needed for it like
 - i) Glassware starter kit consisting of holders, quartz sample tubes etc.
 - ii) EPR tubes, Capillary measurement Kit consisting of capillary tubes, capillary guidance tube, holder, sealing kit.
- 2. Minimum concentration required for solution measurement of organic free radicals and transition metal complexes (Cu(II), Mn(II), Fe(III) complexes etc.) should be specified for both room temperature and 77K measurement.
