If the tender opening date happens to be on a holiday or non-working day due to any other valid reason, the tender opening process will be attended on the next working day at same time and place. IISER Mohali will not be responsible for any error like missing of schedule data while downloading by the Bidder.

- 1. The Online bids should be submitted directly by the original manufacturer/supplier, If quotation is submitted/filled by any representative/agent/dealer then they must upload a authority certificate from the principal company for quoting the price otherwise such quotation will be rejected.
- 2. The quantity mentioned in this inquiry is and shall be deemed to be only approximate and will not in any manner be binding on the Institute. - 3. The rates offered should be FOR Chandigarh/Mohali in case of firms situated outside Chandigarh/Mohali, and free delivery at the Institute premises in case of local firms. Conditional tenders will be summarily rejected.

#### **Technical Specifications for UHPLC System**

UHPLC System consisting of Quaternary Gradient pump, Online Degasser, Auto-sampler, Column Compartment with heating and Cooling Facility, UHPLC Software, with leak detection feature, columns and Accessories as per the following specifications:

#### 1. <u>Quaternary Gradient Pump:</u>

- a. Pump capable of blending up to 04 solvents.
- b. 4-Channel facility in pump with serial/Parallel pistons.
- c. Must be able to work as Isocratic, Binary & Quaternary modes.
- d. Proportionating / Composition Precision:  $\leq 0.15\%$  RSD or less.
- e. Proportionating/ Composition Accuracy:  $\pm \ 0.5\%$  or better.
- f. Operation flow range: Programmable 0.001 to 2 ml /min or better with 0.001 ml/min increments.
- g. Operating pressure Range: 11,500 psi or more.
- h. Flow Precision:  $\leq 0.07\%$  RSD or better.
- i. Flow Accuracy:  $\pm 1\%$  or better.
- j. The pump must have a delay volume 360  $\mu$ L or less.
- k. It should be able to work in pH range from 2 -12 or better.
- 1. Online degasser must be provided along with the pump.
- m. Compressibility compensation should be done automatically.
- n. Solvent selection and gradient formation valve(s) should be included.
- o. User should be able to set the percentages of the solvents to any value from 0 through 100%.
- p. System should allow setting the pump through software.
- q. Should have leak sensor along with light alarm.

#### 2. <u>Auto-sampler:</u>

- a. Number of Sample Capacity: 100 vials or more.
- b. Injection Precision:  $\leq 0.25\%$  RSD at 5 µL or better.
- c. Operating pressure Range: 11,500 psi or more.
- d. Sample Carryover: <0.005% from past sample.
- e. Injection Volume Range 0.1 to 100 µL.
- f. Autosampler Should have Auto-dilution and Auto-derivatization facility.
- g. Should have leak sensor along with light alarm.
- h. Auto cleaning feature of Injection Needle of auto-sampler should also be provided.
- i. Temperature operating range: Ambient Temp. to 40°C.

#### 3. <u>Column Compartment: with suitable heating and cooling facility:</u>

- a. Temperature Control Range: At least 6°C below ambient; up to 80°C or higher temperature.
