4. Firms will quote separately for each article.
5. The rates offered should be FOR Chandigarh/Mohali in case of firms situated outside Chandigarh/Mohali, and free delivery at the Institute premises in case of local firms. Supply outside India please mention the FOB/FCA price clearly.
