- 2. The Quotation should be addressed to the Director IISER Mohali invariably giving on the envelop reference number, last date & time of receipt of tender and date & time of opening of the tender.
- 3. One time importers from China with custom made specifications are highly discouraged.
- 4. The quantity mentioned in this inquiry is and shall be deemed to be only approximate and will not in any manner be binding on the Institute.
- 5. Firms will quote separately for each article.
- 6. The rates offered should be FOR Chandigarh/Mohali, in case of firms situated outside Chandigarh/Mohali, and free delivery at the Institute premises in case of local firms. Suppliers outside India may please mention the FOB/FCA price clearly.
- 7. In case of Ex-godown terms the amount of packaging forwarding freight etc. should clearly be indicated by percentage or lump sum amount. Institute has policy not to make any advance payment towards any purchase, Letter of credit can be opened if required.

Specifications of High-Speed Camera:

Quotations are invited in two bid system for a high frame rate camera system with the below mentioned technical specifications. The technical and Financial bids must be submitted in separate envelops within the stipulated period. Only the financial bid of technically competent quote will be opened for further consideration.

I. A compact light-weight high speed camera system with completer electronics and software

- 1. Frame Rate performance should match at least the description below.
 - 4,000 fps at 1,280 x 1,024 pixel resolution
 - 10,000 fps at 896 x 488 pixel resolution
 - 200,000 fps at 1,280 x 24 pixel resolution
- **2. Sensor must be COLOR:** with ISO color sensitivity of 500 colors with 1,280 x 1,024 pixels, 10um pixel size, 12-bit ADC (Bayer system colour)
- 3. Driving electronics: Should be connected via high speed Gigabit Ethernet.
- **4. Memory**: Camera should have at least **16 GB** memory with a capacity to record at least 8734 consecutive frames with the maximum resolution.
- **5. Mounting:** The lens should be compatible with C-lens mounting system.
- **6. Triggering:** The camera should be triggered with a laser pulse. It should have capacity to operate in burst-mode and repetitive mode.
- 7. Shutter: Global electronic shutter with variable speed up to 1 us.
- **8.** Weight: Should be as light as possible (should be around 1.5 Kg).
- **9. Software Control:** It should be possible to fully control the camera with a software. The software must be provided.
- 10. The installation and training must be provided.

The system should have at least one year warranty with a long term service support in India. The camera should have proven performance. The vendor should provide sufficient documents in this regard.
