- 2. The Quotation should be addressed to the Director IISER Mohali invariably giving on the envelop reference number, last date & time of receipt of tender and date & time of opening of the tender.
- 3. One time importers from China with custom made specifications are highly discouraged.
- 4. The quantity mentioned in this inquiry is and shall be deemed to be only approximate and will not in any manner be binding on the Institute.
- 5. Firms will quote separately for each article.
- 6. The rates offered should be FOR Chandigarh/Mohali, in case of firms situated outside Chandigarh/Mohali, and free delivery at the Institute premises in case of local firms. Suppliers outside India may please mention the FOB/FCA price clearly.

Specifications:

1. Non-Refrigerated Micro-centrifuge

- 1. Compact centrifuge for speed ≥14,500 rpm & RCF ≥20000 x g.
- 2. Rotor for 24 x 0.5, 1.5 and 2ml tubes with aerosol-tight lid.
- 3. Acceleration and deceleration time to attain the maximum speed should not be more than 20 sec.
- 4. The centrifuge should have separate short spin key for quick centrifugation.
- 5. Autoclavable aerosol tight rotor should be supplied with the system.
- 6. Automatic lid opening at the end of run.
- 7. The centrifuge should have soft brake function.
- 8. Power consumption should not more than 250 watt.
- 9. Noise level should be less than 51 dB.
- 10. Supply one additional rotor compatible with 4 x 0.2ml PCR strips.
- 11. Quote optional for sturdy adapters for 24 x 0.5ml tubes.
- 12. The original catalogue specification sheet of the quoted model/version of centrifuge needs to be attached to the bid. Black & white photocopies will not be acceptable. Vendors must provide 2 years of comprehensive warranty in addition to 2 years of AMC.

2. <u>Ultra low temperature freezer</u>

Bids from internationally reputed suppliers/manufactures are invited to procure an upright, ultra low temperature freezer with following specification.

- 1. Capacity: 550-600 liters, fully loaded freezer including racks, cardboard boxes etc.
- 2. Must have minimum 2 cascading compressors of 1 HP each. Power management system with low voltage surge.
- 3. Four shelves and the base should have separate doors (five doors).
- 4. Cabinet insulation should be made up of vacuum insulation paneling/polyurethane foam.
- 5. Lowest attainable temperature should be -86 °C at ambient temperature up to 32 °C.
- 6. Power Consumption should not be more than 8 kWh/day (± 0.4). Heat out put should not be more than 320 W ((± 10).
- 7. Control panel keypad should be at the eye level.
- 8. On off switch and on off alarm should be lockable.
- 9. Temperature should be adjustable with 1°C increments.
- 10. Password controlled set point security should be provided.
- 11. Temperature alarm setting should be adjustable from 50 to 85 $^{\circ}\text{C}.$
- 12. Built in system for fault diagnosis should be provided with the freezer.
- 13. Battery backup for maintaining display and activating alarms during power outages.
- 14. The freezer should have alarm for power failure; to alert low and high temperature, to alert low battery as well as for filter clean up.
- 15. System should be supplied with fully loaded racks, boxes and divider.
- 16. IQ, OQ and PQ along with validation certificate to be provided
- 17. Calibration and validation of equipment required at the time of installation. Additional certification such as CE, UL etc. certificates need to be attached.
- 18. Indian compatible plug with a servo voltage stabilizer should be provided.
- 19. The original catalogue specification sheet of the quoted model/version of freezer needs to be attached to the bid. Black & white photocopies will not be acceptable. Vendors must provide 3 years of comprehensive warranty in addition to 2 years of AMC. However, warranty on compressors and refrigerant should be provided for five years.
