	 The vacuum pump should be capable of 100% oil free transfer. Should be compatible to volatile organic compounds and slightly corrosive gases. Should be equipped with chemically resistant diaphragm made of Polytetrafluoroethylene (PTFE). An ultimate pressure of 7 bar or above should be achievable. The lowest achievable pressure or ultimate vacuum should be 100 mbar or better at atmospheric pressure. Adaptable fine control valves made of stainless steel with pressure gauge and vacuum gauge should be provided. The maximum flow rate of the pump should be 50L/min or better. The pump should operate effectively within a specified temperature range of +5°C to +40°C. Maximum power consumption of the pump should not be more than 100 W

- 3. The rates offered should be FOR Chandigarh/Mohali in case of firms situated outside Chandigarh/Mohali, and free delivery at the Institute premises in case of local firms. Supplier from outside India should mention the Ex-works/FOB/FCA/CIF/CIP price clearly. Conditional tenders will be summarily rejected.
