## BRIEF TERMS :-

1. Every bidder will have to deposit a Refundable Caution Money of Rs. 30,000/- **STRICTLY BY DD/ PAY ORDER** in favour of "REGISTRAR, IISER-MOHALI" payable at "MOHALI". The amount will be forfeited in case the bidder fails to deposit Earnest Money against his accepted bid or found doing any kind of mischief, forming pool or creating disturbance etc. without prejudice to any other legal, administrative action against the miscreants. Entry fee will be returned to unsuccessful buyers.
2. All sales will be made strictly on "As is where is" basis. Once the bid is accepted, no claim will be entertained with regard to quantity, quality, measurements, sizes, models, numbers and weights etc.
3. The Director, IISER-Mohali reserves the right to accept/reject any bids or to add /delete any lot(s) put to Auction without assigning any reasons therefor. In case of any dispute, the Director, IISER-Mohali will be the sole Arbitrator and his decision will be final & binding.
4. The buyers will have to deposit minimum Earnest Money @ 25% (by DD or Pay Order) of the accepted bids immediately on the fall of hammer and balance amount also by DD or Pay Order alongwith applicable GST within 7 Working days and thereafter will be allowed to remove the material from site at their cost & risk.
5. For old and used Transformer/Lubricating Oil and Batteries-Only such units who are actual users and are registered with the M.O.E.F, New Delhi shall be allowed to participate in the Auction. The bidders shall have to produce the original as well as one attested copy from Notary Public of the following documents at the time of lifting of material. These documents shall be checked by Auction Committee at the time of lifting the material.
  - (a) Registration Certificate issued by M.O.E.F, New Delhi as Recycler/reprocessor of hazardous wastes etc.
  - (b) Consent under water and air acts and authorization under hazardous wastes (Management & handling) rules-1989 and amendments thereof from the respective State Pollution Control Boards.
  - (c) The bidder shall produce the log book duly endorsed by the previous sellers for the quantity of oil purchased till date.
  - (d) Quantity of recyclable waste shall not exceed the prescribed limit as per certificate issued by the M.O.E.F, New Delhi.
