For higher throughput, Instrument must be capable of unattended extraction of 4 samples in parallel.2. Integrated solvent controller allows mixing and delivery of up to two solvents3. For faster extraction process, the instrument should be able to work at variable high pressures upto 300 bar and at an elevated temperatures upto 300 deg C. It should have built-in over pressure mechanism.4. Instrument must be able to extract from samples of size upto 150 mL.5.
