	1. Helium purity:	
	(a) must be 99.999% or better.	
	(b) Oxygen and moisture content should not be greater than 2ppm.	
	(c) Nitrogen content must not be more than 3 ppm.	
	(d) Any other foreign material/impurity should be less than 0.1-0.2 ppm. The composition	
	of all such components must be clearly written in the technical bid.	
	2. Packaging and delivery:	
	(a) The liquid volume measured at the customer site after delivery will be considered as the volume	
	for which payment will be made. This should not be less than 90% of the ordered volume of liquid.	
	(b) The liquid must be delivered in dewars of capacity 100 liters or 200 liters or 250 liters.	
	(c) Appropriate adapters should be provided so that the transfer tubes available in IISER Mohali	
	can be used for transferring liquid from the dewar to other cryostats.	
	(d) If the dewar volume is more than 100 liter, the same will need to be kept in the IISER Mohali labs for 7 days.	
	(e) Delivery charges must be specified separately including applicable taxes.	
	(f) The dewars must have appropriate safety valves installed. Appropriate ports for pressurizing and	
	venting should also be provided. The vendor should also provide a high purity (99.99%) helium gas	
	cylinder with the tank for pressurizing the helium dewar.	
	The vendors should also note that the estimated requirement of liquid helium will be around 500	
	liters per month. This may be delivered twice in 250 liter dewars with high purity (99.99%) helium	
	gas cylinder or whatever is convenient for IISER Mohali. Depending on the performance of the	
	vendor, the contract may be considered for renewal.	
	(g) The liquid Helium must be delivered within 10 days from the date of purchase order. If the	
	vendor fails to do so, two times in a year, the rate contract may be cancelled by IISER Mohali.  (h) The liquid will be considered "received" only if the volume measured at IISER Mohali is not	
	less than the ordered volume.

- 1. The online updated Price BOQ is in INR format. If bidder want to quote other than INR please specify the quoted currency in the technical bid/part and fill the amount in same updated BOQ.
- 2. Please bifurcate the price on shipping terms i, e, Ex-works -> FCA/FOB -> CIP/CIF in price BOQ and specify the same in technical bid.

IISER Mohali will not be responsible for any error like missing of schedule data while downloading by the Bidder.
- III. The bidder shall upload the tender documents duly filled in and stamped by the authorized signatory on each and every page. Tender not submitted/uploaded in the prescribed form and as per the tender terms and conditions shall be liable for rejection.

- IV. The bidder shall upload scanned copy of the PAN Card, GST number duly signed and stamped.
- V. E-procurement system ensures locking on the scheduled date and time. The system will not accept any bid after the scheduled date and time of submission of bid.
