- 30. IPS should be able to detect and prevent embedded threats with SSL traffic.
- 31. The NGFW should be managed by single management and single console along with built in Logging & Reporting option or different appliance can be quoted for Management and Logging.
- 32. NGFW Management/logging appliance should have minimum Log storage of 2 TB HDD.
- 33. Firewall should support management of firewall policies via Cli, Ssh & inbuilt GUI management interface.
- 34. Firewall should support the functionality of Auto-Update to check for latest software versions & download the same.
- 35. The proposed solution must be an Appliance based solutions with capability to handle 8 GB per day logs.
- 36. Firewall should be ICSA certified
- 37. The proposed solution should be recommended by NSS Labs.
- 38. The complete solution must be quoted with 5 year subscription, support and warranty.

Terms and conditions of tender:

- 7. Comprehensive training of our staff on management and usage of the equipment is to be provided on site. Detailed documentation and quick reference cards should be provided as a part of this training.

- 3. The rates offered should be FOR Chandigarh/Mohali in case of firms situated outside Chandigarh/Mohali, and free delivery at the Institute premises in case of local firms. Supplier from outside India should mention the Ex-works/FOB/FCA/CIF/CIP price clearly. Conditional tenders will be summarily rejected.
