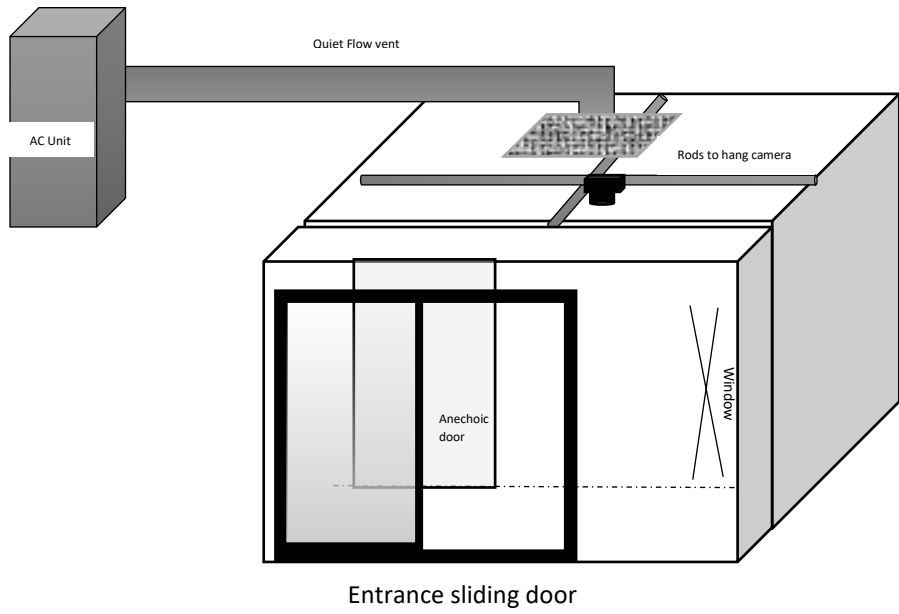
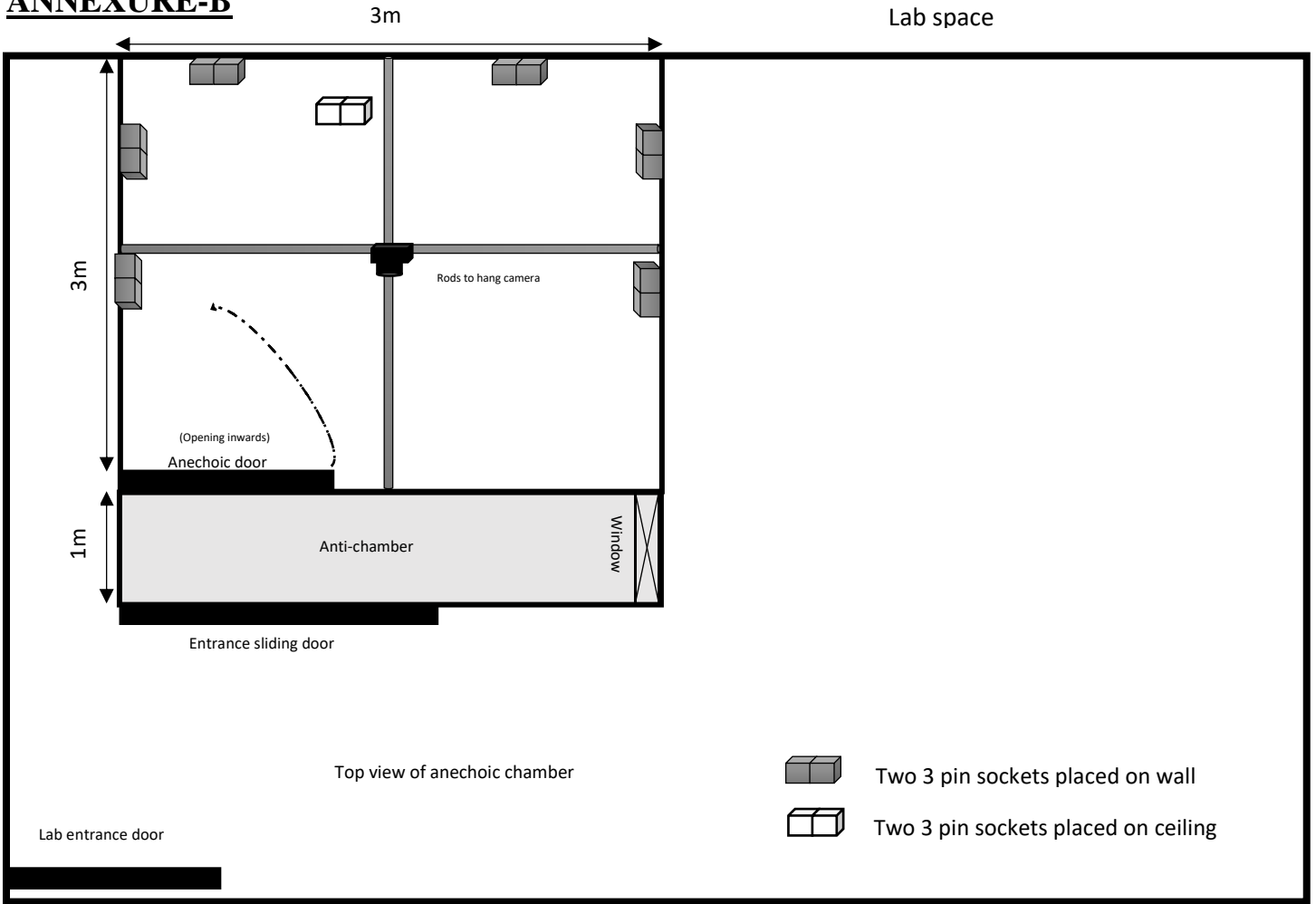

## ANNEXURE-A

Anechoic chamber to be installed inside lab situated on the 2<sup>nd</sup> floor (3<sup>rd</sup> level). Design, development, fabrication or modular acoustic panels for anechoic chamber with quiet flow ventilation system with split AC. Installation and testing required. Diagram.

<b>Features</b>	<b>Requirement</b>
1. Dimension of inner chamber	3 X 3 x 2.7 m <sup>3</sup> (LXBXH)
2. Type of Acoustic chamber	Fully anechoic
3. Test specimens	Tiny live insects (15 mm size)
4. Sound source level (dB)	40 – 100 dB
5. Average ambient noise level outside of chamber	60 – 70 dB (A weighted All Pass)
6. Desired ambient noise level	Less than or equal to 30 dB
7. Inside the chamber	(A weighted All Pass)
8. Desired cut off Frequency (Hz)	500 Hz and below
9. Temperature control	Required. Air Conditioner system to be placed outside chamber (outdoor unit and blower both). Air flow to chamber through quiet flow vents. Temperature regulator required.
10. Ventilation	Suitable Exhaust, Air grills, Damper control with acoustically treated quiet flow duct/silencer to maintain interior temperature
11. Walls, Floor and Ceiling specifications	All absorbent. Walls and ceiling with perforated wedges with suitable felt/cloth cladding. Floor walkable with thick carpet and no wedges.
12. Isolation	Desirable. Springs (3 Hz).
13. Door	One soundproof, swinging inwards.
14. Anti-chamber	Yes. 1 X 3 X 2.7 m <sup>3</sup> with 1 sliding door and 1 window
15. Electrical fittings	230 V, 3 pin type (10/20 amp); 14 nos
16. Lighting	White light panels (350 lux approx.); Concealed electrical conduits
17. Additional features	Suitable inlets/holes for wires of equipment to pass into chamber from the anti-chamber minimizing acoustic leakage; CCTV Camera mounted on ceiling (centre); provision to slide camera to other positions is desirable.
18. SAFETY PRECAUTION	Alarm buzzer to alert members outside in case of emergency in chamber
<b>19. IMPORTANT REQUIREMENT</b>	Since the specimens to be tested in the chamber are live insects that are sensitive to harsh chemical and odour it is most important to ensure the following: <ol style="list-style-type: none"><li>1) <b>No insect repellents</b></li><li>2) <b>No strong adhesive</b></li><li>3) <b>No strong odour</b></li><li>4) <b>No strong chemical to be present on the inner side of the chamber</b></li></ol> Failing this the payment shall be withheld as the chamber would be unusable
