GENERAL CONDITIONS OF THE RFQ

- 1. The rates shall be quoted in the enclosed schedule of quantities and duly signed by the contractor.
- 2. Rates to be inclusive of GST, etc.
- 3. Quotations must be submitted in two bid system i.e, Technical & Commercial, otherwise, their bid will be rejected.

4. Eligibility Criteria

- a) The agency must be OEM / Authorized dealer of any one Make i.e. Glo-line/ Paras Line / Glow-shine.
- b) Contractors/firms should have successfully completed, during last 7 years ending last day of the month previous to the one in which the bidding are invited, either three similar works costing not less than 40% or two similar works costing not less than 50% and one similar work costing not less than 80% of the estimated cost of the work, of at least one should be in Govt./Semi Govt/PSU/Autonomous Body. Similar work means "P/f of Photo luminescent fire escape route signage."
- c) Average annual financial turn over during the last 3 (three) years ending 31st March of the previous year should at least be 50% of the estimated cost of work.
- d) Not incurred loss in more than two years during the last five years ending 31st March of the previous year.
- 5. Rates to remain firm during the duration of work as well as for the extended period, if any. No escalation in rates will be allowed in any circumstances.
- 6. The firm should note that building escape route drawing has to be printed on the plate which will be provided by the Institute. The firm may also have to undertake designing of the escape route/plate format for which no extra payment shall be made.
- 7. The contractor shall comply with all statutory requirements in respect of said work.
- 8. The quantity can be increase or decrease.
- 9. The work shall be for the period of four weeks to be reckoned from the day of issue of award letter.
- 10. The agency must undertake the work by taking all precaution for social distancing.
- 11. Penalty of 0.5% per week shall be imposed for delay in work.
- 12. EMD of Rs.3,800/- in favour Registrar IISER Mohali or MSME relevant to work.
