1. Quotations must be submitted in two bid system i.e, technical and commercial, otherwise, their bid will be rejected.
2. Agency must have executed at least one similar work (MS fabrication) valuing 80% (65,120/-) directly in any Govt/ Autonomous/PSU department / organization.
3. Valid PAN/GST number
4. The rates shall be quoted in the enclosed schedule of quantities and duly signed by the contractor.
5. Work to be carried out strictly as per the specifications.
6. Rates to remain firm during the duration of work as well as for the extended period, if any. No escalation in rates will be allowed in any circumstances.
7. The contractor shall comply with all statutory requirements in respect of said work.
8. Safety of workers will be the sole responsibility of the contractor
9. The quantity can be increase or decrease.
10. The work shall be for the period of three weeks to be reckoned from the day of issue of award letter.
11. Rates should be inclusive of GST.
