GENERAL CONDITIONS OF THE RFQ

1. Quotations must be submitted in two bid system i.e, technical and commercial, otherwise, their bid will be rejected.
2. Contractors/firms should have successfully completed, during last 7 years ending last day of the month previous to the one in which the bidding are invited, either three similar works costing not less than 40% or two similar works costing not less than 50% and one similar work costing not less than 80% of the estimated cost of the work, of at least one should be in Govt./Semi Govt/ PSU/ Autonomous Body. Similar work means “Repair work of Electromechanical Components.
3. Valid PAN/GST number
4. The rates shall be quoted in the enclosed schedule of quantities and duly signed by the contractor.
5. Work to be carried out strictly as per the specifications.
6. Rates to remain firm during the duration of work as well as for the extended period, if any. No escalation in rates will be allowed in any circumstances.
7. The contractor shall comply with all statutory requirements in respect of said work.
8. Safety of workers will be the sole responsibility of the contractor
9. The quantity can be increase or decrease.
10. The work shall be for the period of five weeks to be reckoned from the day of issue of award letter.
11. Rates should be inclusive of GST.
12. EMD amounting to Rs.2,700/- in favour of Registrar IISER, Mohali payable at Chandigarh.
