Tender shall be submitted by the Bidders in two parts:

(i) Technical Bid. - Cover I (ii) Financial Bid. - Cover II

The two bid system will be followed for this tender. In this system the bidder must submit bid on line at E-Procurement Portal (i.e. https://eprocure.gov.in/eprocure/app) his offer in two covers. "Cover No. 1-Technical Bid along with requisite fee details and all forms under seal and signature of Bidder" mentioned below and "Cover No.2 - Financial Bid" respectively.

The **Cove I** (Technical Bid) shall consist of following:

i) <u>Earnest Money</u> -The bidder shall furnish as part of its bid, an EMD of Rs. 1,04,100.00/- (Rupees one lakh four thousand and one hundred only). NOTICE INVITING TENDER

1. Online percent rate tenders are invited on behalf of the Director IISER Mohali from approved and eligible contractors of C.P.W.D. and those of appropriate list of Department Posts and Telecommunications, U.T. Administration, Chandigarh Housing Board, State PWD's, Autonomous body for the work of "Operation 24x7 of Substations, DG sets, Pump houses, and STP's installed at IISER Mohali"

The enlistment of the contractors should be valid on the last date of tenders.

In case only the last date of sale of tender is extended, the enlistment of contractor should be valid on the original date of sale of tenders.

In case both the last date of receipt of application and sale of tenders are extended, the enlistment of contractor should be valid on either of the two dates i.e. original date of sale of tender or on the extended date of sale of tenders.

- 1.1 The work is estimated to cost Rs.52,02,973.00/-, plus GST. This estimate, however, is given merely as a rough guide
 - 1.1.1. The authority competent to approve NIT for the combined cost and belonging to the major discipline will consolidate NITs for calling the tenders. He will also nominate Division which will deal with all matters relating to the invitation of tenders.

For composite tender, besides indicating the combined estimated cost put to tender, should clearly indicates the estimated cost of each component separately. The eligibility of tenderer will correspond to the combined estimated cost of different components put to tender.

1.2 CRITERIA OF ELIGIBILITY

- 1.2.1 Bidder shall submit the EMD of Rs.1,04,100/- favoring Registrar, IISER Mohali and payable at Mohali.
- NB- Original DD sends at Executive Engineer, IISER Mohali, Sector 81, Knowledge City, SAS Nagar, Mohali.
- 1.2.2. The tender shall be received by the undersigned by on 12.06.2021 up to 3:00 PM and envelope No. 1 only containing earnest money, conditions and tender documents shall be opened on the next working day. No consideration will be given to a tender received after the above stipulated time and date. Eligibility related documents shall be evaluated for criteria stipulated at 1.2.3 and agencies / contractors will accordingly be qualified/ disqualified by the competent Authority. The financial bid (Envelope No 2) of qualified tenderer shall then be opened at notified time, date.
- 1.2.3 Contractors who fulfill the following criteria shall be considered by IISER Mohali for technical evaluation (if required) and opening of commercial bids:
 - I) Contractors /firms should have successfully completed directly during last 7 years ending last day of the month previous to the one in which the bidding are invited, either three similar works costing not less than 40% i.e. Rs.20.81 lacs or two similar works costing not less than 50% i.e. Rs.26.01 lacs or one similar work costing not less than 80% i.e. Rs.41.62 lacs of the estimated cost of the work out of which at least one should have been executed in Govt departments. Relevant work orders for the work experience (alongwith completion certificate, as uploaded) may also be uploaded to make/distinguish the quantum of similar work executed by the contractor.
- II) Average annual financial turn over during the last 3 (three) years ending 31st March of the previous year should at least be 50% of the estimated cost of work.
- III) Not incurred loss in more than two years during the last five years ending 31st March of the previous year.
- IV) Work has to be carried out as per the guidelines for COVID-19 issued by MHA.
- V) Integrity pact as per attached.
- VI) Valid ESI/ EPF number
- VII) Undertaking to obtain Electrical/ HT LT licence and labour licence from Govt, after work is awarded to them within a month.

1.2.4 Eligibility criteria:

I/We undertake and confirm that eligible similar works(s) has/have not been got executed through another contractor on back to back basis. Further that, if such a violation comes to the notice of Department, then I/we shall be debarred for tendering in the Institute in future forever. Also, if such a violation comes to the notice of Department before date of start of work, the Engineer-in-Charge shall be free to forfeit the entire amount of Earnest Money Deposit/Performance Guarantee.

For the purpose of clause Similar work means "Manning of Operation of establishments like Substations, DG sets, Pump houses, and STP's".

- 2. Agreement shall be drawn with the successful tenderer on General Conditions of Contract for works which is available from the Engineer-in-Charge. Tenderer shall quote their rates as per various terms and conditions of the said form which will form part of the agreement.
- 3. The time allowed for carrying out the work will be 12 Months from the date of start as defined in schedule 'F' or from the first date of handing over of the site, whichever is later, in accordance with the phasing, if any, indicated in the tender documents. Work is further extendable for 1+1 years based on satisfactory performance and mutual consent.
- 4. The site for the work is available

OR

The site for the work shall be made available in parts as specified below:-

- a. Tender document consisting of plans, specifications, the schedule of quantities of the various classes of work to be done and the set of terms & conditions of contract to be downloaded from website.
- 5. i) Tenders shall be accompanied with Earnest money of Rs.1,04,100/- by way of Receipt Treasury Challan/Deposit at Call receipt of a scheduled bank/fixed deposit receipt of a scheduled bank/demand draft of a scheduled bank issued in favour of the Registrar, IISER Mohali, Payable at Mohali. 50% of earnest money or Rs.20 lakh, whichever is less, will have to be deposited in the shape prescribed above and balance amount of earnest money can be accepted in the form of Bank guarantee issued by a scheduled bank having validity for 6 months or more from the last date of receipt of tenders
- 6. The contractor whose tender is accepted, will be required to furnish performance guarantee of 5% (Five Percent) of the tendered amount within the period specified in Schedule F. This guarantee shall be in the form of cash (in case guarantee amount is less than Rs.10000/-) or Deposit at Call receipt of any scheduled bank/Banker's cheque of any scheduled bank/Demand Draft of any scheduled bank/Pay order of any scheduled bank (in case guarantee amount is less than Rs.1,00,000/-) or Government Securities or Fixed Deposit Receipts or Guarantee Bonds of any Scheduled Bank or the State Bank of India in accordance with the prescribed form. In case the contractor fails to deposit the said performance guarantee within the period as indicated in Schedule 'F'. including the extended period if any, the Earnest Money deposited by the contractor shall be forfeited automatically without any notice to the contractor.

Tenderers are advised to inspect and examine the site and its surroundings and satisfy themselves before submitting their tenders as to the nature of the ground and sub-soil (so far as is practicable), the form and nature of the site, the means of access to the site, the accommodation they may require and in general shall themselves obtain all necessary information as to risks, contingencies and other circumstances which may influence or affect their tender. A tenderer shall be deemed to have full knowledge of the site whether he inspects it or not and no extra charge consequent on any misunderstanding or otherwise shall be allowed. The tenderer shall be responsible for arranging and maintaining at his own cost all materials, tools & plants, water, electricity access, facilities for workers and all other services required for executing the work unless otherwise specifically provided for in the contract documents. Submission of a tender by a tenderer implies that he has read this notice and all other contract documents and has made himself aware of the scope and specifications of the work to be done and of conditions and rates at which stores, tools and plant, etc. will be issued to him by the Institute and local conditions and other factors having a bearing on the execution of the work.

- 7. The competent authority does not bind itself to accept the lowest or any other tender and reserves to itself the authority to reject any or all the tenders received without the assignment of any reason. All tenders in which any of the prescribed condition is not fulfilled or any condition including that of conditional rebate is put forth by the tenderer shall be summarily rejected.
- 8. Canvassing whether directly or indirectly, in connection with tenders is strictly prohibited and the tenders submitted by the contractors who resort to canvassing will be liable to rejection.
- 9. The competent authority reserves to himself the right of accepting the whole or any part of the tender and the tenderer shall be bound to perform the same at the rate quoted.
- 10. The contractor shall not be permitted to tender for works in the Institute's Engineering Department (responsible for award and execution of contracts) in which his near relative is posted as Divisional Accountant or as an officer in any capacity between the grades of Executive Engineer and Junior Engineer (both inclusive). He shall also intimate the names of persons who are working with him in any capacity or are subsequently employed by him and who are near relative to any Group A & B officer in the Institute's Engineering Department. Any breach of this condition by the contractor would render him liable to be removed from the approved list of contractors of this Institute/debarring for further tendering in the Institute for at least 5 years.
- 11. No Engineer or other officers employed in Engineering or Administrative duties in Engineering Department of the Institute is allowed to work as a contractor for a period of one year after his retirement from Institute's service without the previous permission of the competent authority in writing. This contract is liable to be canceled if either the contractor or any of his employees is found at any time to be such a person who had not obtained the permission of the competent authority as aforesaid before submission of the tender or engagement in the contractor's service.
- 12. The tender for the works shall remain open for acceptance for a period of One hundred twenty (120) days from the date of opening of tenders/ One hundred twenty days from the date of opening of financial bid in case tenders are invited on 2/3 envelop system (strike out as the case

may be) if any tenderer withdraws his tender before the said period or issue of letter of acceptance, whichever is earlier, or makes any modifications in the terms and conditions of the tender which are not acceptable to the department, then the Institute shall, without prejudice to any other right or remedy, be at liberty to forfeit 50% of the said earnest money as aforesaid. Further the tenderer shall not be allowed to participate in the re-tendering process of the work.

- 13. This Notice inviting tender shall form a part of the contract document. The successful tenderer/contractor, on an acceptance of his tender by the Accepting Authority, shall within 15 days from the stipulated date of start of the work sign the contract consisting of:
 - a) The Notice Inviting Tender, all the documents including additional conditions, specifications and drawings, if any, forming the tender as issued at the time of invitation of tender and acceptance thereof together with any correspondence leading thereto.
 - b) Standard Form 7/8.

For Composite Tenders

- 16.1.1 The Engineer Incharge of the major component will call tenders for the composite work. The cost of tender document and Earnest Money will be fixed with respect to the combined estimated cost put to tender for the composite tender.
- 16.1.2 The tender document will include following three components:
- Part A:- Form-6, Form-7/8 including schedule A to F for major component of the work, Standard General Conditions of Contract or latest edition as applicable with all amendments/modifications.
- Part B:- General/specific conditions, specifications and schedule of quantities applicable to major component of the work.
- Part C: Schedule A to F for minor component of the work. (Engineer in charge of major component shall also be competent authority under clause 2 and clause 5 as mentioned in schedule A to F for major components) General/specific conditions, specifications and schedule of quantities applicable to minor component(s) of the work.
- 16.1.3The tenderer must associate with himself, agencies of the appropriate class eligible to tender for each of the minor component individually.

The eligible tenderers shall quote rates in terms of overall percentage above or below the total estimated amount put to tender must be filled both in figures and words on the last page of schedule of quantities. It will be obligatory on the part of the tenderer to sign the tender document for all the components (The schedule of quantities, conditions and special conditions etc.)

16.1.5 After acceptance of the tender by competent authority, the Engineer in charge of major component of the work shall issue letter of award on behalf of the Director. After the work is awarded, the main contractor will have to enter into one agreement with Engineer in charge of major component and has also to sign two or more copies of agreement depending upon number of Engineer Incharge of minor components. One such signed set of agreement shall be handed over to Engineer in charge of minor component. Engineer Incharge of major component will operate part A and part B of the agreement. Engineer in charge of minor component(s) shall operate Part C along with Part A of the agreement.

- 16.1.6 Entire work under the scope of composite tender including major and all minor components shall be executed under one agreement.
- 16.1.7 Security Deposit will be worked out separately for each component corresponding to the estimated cost of the respective component of works. The Earnest Money will become part of the security deposit of the major components of work.
- 16.1.8 The main contractor has to associate agency(s) for minor component(s) conforming to eligibility criteria as defined in the tender document and has to submit detail of such agency(s) to Engineer-in-charge of minor component(s) within prescribed time. Name of the agency(s) to be associated shall be approved by Engineer-in-charge of minor component(s).
- 16.1.9 In case the main contractor intends to change any of the above agency/agencies during the operation of the contract, he shall obtain prior approval of Engineer-in-charge of minor component. The new agency/agencies shall also have to satisfy the laid down eligibility criteria. In case Engineer-in-charge is not satisfied with the performance of any agency, he can direct the contractor to change the agency executing such items of work and this shall be binding on the contractor.
- 16.1.10 The main contractor has to enter into agreement with the contractor(s) associated by him for execution of minor component(s). Copy of such agreement shall be submitted to Hospital Engineer in charge of each minor component as well as to Engineer in charge of major component. In case of change of associate contractor, the main contractor has to enter into agreement with the new contractor associated by him.
- 16.1.11 Running payment for the major component shall be made by Engineer-in-Charge of major discipline to the main contractor. Running payment for minor components shall be made by the Engineer-in-Charge of the discipline of minor component directly to the main contractor.
- 16.1.12 Monthly bill of whole work shall be finalized and paid by the Engineer-in-Charge of major component. Engineer(s) in charge of minor component(s) will prepare and pass this final bill for their component of work and pass on the same to the Engineer-in-Charge of major component for including in the final bill for composite contract.
- 16.1.13 It will be obligatory on the part of the tenderer to sign the tender document for all the components before the first payment is released.

No price preference to any corporate society/Registered society, Govt. Public Sector undertakings / bodies shall be given and tenders shall be exclusively dealt with on merit.

The contractor shall comply with the provisions of the Apprentices Act 1961, minimum wages Act 1948, Workmen's compensation Act 1923, contract labour (Regulation and Abolition Act 1970), payment of wages Act 1938, Employer's liability Act 1938, Maternity Benefits Act 1961, and the Industrial disputes Act 1947 as applicable and the rules and regulations issued there under and by the local Administration / Authorities from time to time as well all provisions of law applicable to workmen. Failure to do so shall amount to breach of the contract and the Engineer-in-Charge may at his discretion terminate the contract. The Contractor shall also be liable for any pecuniary liability arising on account of violation by him of any of the said Acts and shall

indemnify the Institute on that account. Institute will not be liable for any act or omission on the part of the contractor in so far as any violation of any of the aforementioned acts.

Each tenderer shall submit only one tender; either by him or as partners in a joint venture. A tenderer who submits or participates in more than one tender will be disqualified.

Unless otherwise stated, the contract shall be for the whole work as described in the "Schedule of items of Works" and the drawings. The contractor shall be bound to complete the whole work as described in the schedule of items of works and the drawings, including additional items, if any, as per drawings and instructions. The issuance of certificate of completion as issued by the Engineer-in-Charge shall be mandatory and will be conclusive proof of completion of work.

The contractor shall get the appended structural drawing proof checked from structural Engineer before commissioning the work and hand over the design details to the Engineer-in-charge.

Interpretations, corrections and changes to the Tenders Documents shall be made by Addendum, if required at E-Procurement portal on https://eprocure.gov.in/eprocure/app

Each Tenderer shall ascertain prior to submitting his Tender that he has received all Addenda issued and he shall so acknowledge their receipt in his Tender.

Bidder shall submit the documents in .pdf format:

- i) Demand draft/Deposit at call receipt from a Scheduled Bank towards earnest money.
- ii) Partnership deed or Registration Certificate of the Firm or Company as the case may be.
- iii) Power of Attorney

The provisions in the Tender documents shall govern over the contents of the above paragraphs if in contradiction or variation.

The contractor shall comply with the provisions of prevalent ESI Act.

1. All works proposed for execution of contract will be notified in a form of invitation to tender pasted in public places and signed by the officer inviting tender or by publication in Newspapers as the case may be.

This form will state the work to be carried out, as well as the date for submitting and opening tenders and the time allowed for carrying out the work, also the amount of earnest money to be deposited with the tenderer, and the amount of the security deposit and performance guarantee to be deposited by the successful tenderer and the percentage, if any, to be deducted from bills: Copies of the specifications, designs and drawings and any other documents required in connection with the work signed for the purpose of identification by the officer inviting tender shall also be opened for inspection by the contractor at the office of officer inviting tender during office hours.

- 2. In the event of the tender being submitted by a firm, it must be singed separately by each partner thereof or in the event of the absence of any partner, it must be singed on his behalf by a person holding a power-of attorney authorizing him to do so, such power of attorney to be produced with the tender, and it must disclose that the firm is duly registered under the Indian Partnership Act, 1952.
- 3. Receipts for payment on account of work, when executed by a firm, must also be signed by all the partners, except where contractors are described in their tender as a firm, in which case the receipts must be signed in the name of the firm by one of the partners, or by some other person having due authority to give effectual receipts for the firm.

No single tender shall include more than one work, but contractors who wish to tender for two or more works shall submit separate tender for each. The rate(s) must be quoted in decimal coinage. Amounts must be quoted in full rupees by ignoring fifty paise and considering more than fifty paise as rupee one.

- 4 A. In case of Percentage Rate Tenders, tenderer shall fill up the usual printed form, stating at what percentage below/above (in figures as well as in words) the total estimated cost given in Schedule of Quantities at Schedule –A, he will be willing to execute the work. The tenders submitted shall be treated as invalid if:
- (i) The contractor does not quote percentage above/below on the total amount of tender or any section/sub head of the tender.
- (ii) The percentage above/below is not quoted in figures & words both on the total amount of tender or any section/sub head of the tender.
- (iii) The percentage quoted above/below is different in figures & words on the total amount of tender or any section/sub head of the tender:-

Tenders, which propose any alteration in the work specified in the said form of invitation to tender, or in the time allowed for carrying out the work, or which contain any other conditions of any sort including conditional rebates, will be summarily rejected. No single tender shall include more than one work, but contractors who wish to tender for two or more works shall submit separate tender for each. Tender shall have the name and number of the works to which they refer, written on the envelopes.

4B. In case the lowest tendered amount (estimated cost + amount worked on the basis of percentage above/below) of two or more contractors is same, such lowest contractors will be asked to submit sealed revised offer in the form of letter mentioning percentage above/below on estimated cost of tender including all sub sections/sub heads as the case may be, but the revised percentage quoted above/below on tendered cost or on each sub section/sub head should not be higher than the percentage quoted at the time of submission of tender. The lowest tender shall be decided on the basis of revised offers.

In case any of such contractor refuses to submit revised offer, then it shall be treated as withdrawal of his tender before acceptance and 50% of earnest money shall be forfeited.

If the revised tendered amount of two or more contractors received in revised offer is again found to be equal, the lowest tender, among such contractors, shall be decided by draw of lots in the presence of Engineer-in-charge of major & minor component(s) (also Director, IISER in case Horticulture work is also included in the tender).

In case all the lowest contractors those have quoted same tendered amount, refuse to submit revised offers, then tenders are to be recalled after forfeiting 50% of EMD of each contractor.

Contractor(s), whose earnest money is forfeited because of nonsubmission of revised offer, shall not be allowed to participate in the re-tendering process of the work.

- 5. The officer inviting tender or his duly authorized assistant will open tenders in the presence of any intending contractors who may be present at the time, and will enter the amounts of the several tenders in a comparative statement in a suitable form. In the event of a tender being accepted, a receipt for the earnest money shall thereupon be given to the contractor who shall thereupon for the purpose of identification sign copies of the specifications and other documents mentioned in Rule-I. In the event of a tender being rejected, the earnest money shall thereupon be returned to the contractor remitting the same, without any interest.
- 6. The officer inviting tenders shall have the right of rejecting all or any of the tenders and will not be bound to accept the lowest or any other tender.
- 7. The receipt of an accountant or clerk for any money paid by the contractor will not be considered as any acknowledgment or payment to the officer inviting tender and the contractors shall be responsible for seeing that he procures a receipt signed by the officer inviting tender or a duly authorized Cashier.
- 8. The memorandum of work tendered for and the schedule of materials to be supplied by the department and their issue-rates, shall be filled and completed in the office of the officer inviting tender before the tender form is issued. If a form is issued to an intending tenderer without having been so filled in and incomplete, he shall request the officer to have this done before he completes and delivers his tender.
- 9. The tenderer shall sign a declaration under the officials Secret Act 1923, for maintaining secrecy of the tender documents drawings or other records connected with the work given to them. The unsuccessful tenderer shall return all the drawings given to them.

10 In the case of Item Rate Tenders, only rates quoted shall be considered. Any tender containing percentage below/above the rates quoted is liable to be rejected. Rates quoted by the contractor in item rates tender in figures and words shall be accurately filled in so that there is no discrepancy in the rates written in figures and words. However, if a discrepancy is found, the rates which correspond with the amount worked out by the contractor shall unless otherwise proved be taken as correct. If the amount of an item is not worked out by the contractor or it does not correspond with the rates written either in figures or in words then the rates quoted by the contractor in words shall be taken as correct. Where the rates quoted by the contractor in figures and in words tally but the amount is not worked out correctly, the rates quoted by the contractor will unless otherwise proved be taken as correct and not the amount. In even no rate has been quoted for any item(s), leaving space both in figure(s), word(s) and amount blank, it will be presumed that the contractor has included the cost of this/these item(s) in other items and rate for such item(s) will be considered as zero and work will be required to be executed accordingly.

10A. In case of Percentage Rate Tenders only percentage quoted shall be considered. Any tender containing item rates is liable to be rejected. Percentage quoted by the contractor in percentage rate tender shall be accurately filled in figures and words, so that there is no discrepancy.

- 11. In the case of any tender where unit rate of any item/items appear unrealistic, such tenders will be considered as unbalanced and in case the tenderer is unable to provide satisfactory explanation such a tender is liable to be disqualified and rejected.
- 12. All rates shall be quoted on the tender form. The amount for each item should be worked out and requisite totals given. Special care should be taken to write the rates in figures as well as in words and the amount in figures only, in such a way that interpolation is not possible. The total amount should be written both in figures and in words. In case of figures, the word 'Rs.' should be written before the figure of rupees and word 'P' after the decimal figures, e.g. 'Rs. 2.15 P' and in case of words, the word, 'Rupees' should precede and the word 'Paise' should be written at the end. Unless the rate is in whole rupees and followed by the word 'only' should invariably be upto two decimal places. While quoting the rate in Schedule of quantities, the word only should be written closely following the amount and it should not be written in the next line.

Applicable for Percentage Rate Tender only (Form- 7)

- 12A.In Percentage Rate Tender, the tenderer shall quote percentage below/above (in figures as well as in words) at which he will be willing to execute the work. He shall also work out the total amount of his offer and the same should be written in figures as well as in words in such a way that no interpolation is possible. In case of figures, the words 'Rs' should be written before the figures of rupees and word P after the decimal figures, e.g. 'Rs. 2.15P and in case of words, the word 'Rupees' should precede and the word 'Paise' should be written at the end.
- 13.(i) The Contractor whose tender is accepted, will be required to furnish performance guarantee of 5% (Five Percent) of the tendered amount within the period specified in Schedule F. This guarantee shall be in the form of Deposit at call receipt of any scheduled bank/Banker's cheque of any scheduled bank/Demand Draft of any scheduled bank/Pay order of any scheduled bank (in case guarantee amount is less than Rs. 1,00,000/-) or Government Securities or Fixed Deposit Receipts or Guarantee Bonds of any Scheduled Bank or the State Bank of India in accordance with the prescribed form.
- (ii) The contractor whose tender is accepted will also be required to furnish by way of Security Deposit for the fulfillment of his contract, an amount equal to 5% of the tendered value of the work. The Security deposit will be collected by deductions from the running bills of the contractor at the rates mentioned above and the earnest money deposited at the time of tenders, will be treated as a part of the Security Deposit. The Security amount will also be accepted in the shape of Government Securities. Fixed Deposit Receipt of a Scheduled Bank or State Bank of India will also be accepted for this purpose provided confirmatory advice is enclosed.
 - 14. On acceptance of the tender, the name of the accredited representative(s) of the contractor who would be responsible for taking instructions from Engineer-in-Charge shall be communicated in writing to the Engineer-in-Charge.
 - 15. Turnover tax, GST or any other tax on material in respect of this contract shall be payable by the Contractor and the Institute will not entertain any claim whatsoever in respect of the same.
 - 16. The contractor shall give a list of employees in IISER related to him.
- 1. The tender for the work shall not be witnessed by a contractor or contractors who himself/themselves has/have tendered or who may and has/have tendered for the same work. Failure to observe this condition would render, tenders of the contractors tendering, as well as witnessing the tender, liable to summary rejection.
- 18. The tender for composite work includes in addition to building work all other works such as sanitary and water supply installations drainage installation, electrical work, horticulture work,

roads and path etc. The tenderer apart from being a registered contractor (B & R) of appropriate class, must associate himself with agencies of appropriate class which are eligible to tender for sanitary and water supply drainage, electrical and horticulture work in a composite tender subject to the approval of the institute.

- 20. The contractor shall comply with the provisions of the Apprentices Act 1961, and the rules and orders issued there under from time to time. If he fails to do so, his failure will be a breach of the contract and the Engineer Incharge may in his discretion without prejudice to any other right or remedy available in law cancel the contract. The contractor shall also be liable for any pecuniary liability arising on account of any violation by him of the provisions of the said Act.
- 23. Every tender shall be written in the English language. All other information such as documents and drawings supplied by the tenderer will also be in the English language only. Drawings and designs shall be dimensioned according to the metric system of measurements. Tenders shall be forwarded under cover or a letter typewritten on the tenderer's letterhead and duly signed by the tenderer. Signature must be in long hand executed in ink by a duly authorized principal of the tendering firm. No oral, telegraphic or telephonic tenders or subsequent modifications there to shall be entertained.
 - 24. The tenderer shall sign of every page of the tender documents in taken of acceptance of tender conditions and for the purpose of identification. Tenders containing erasures and alterations of the tender documents are liable to the rejected unless these are authenticated by the person signing the Tender Documents.
 - 25. The tenderer shall not be entitled to claim any costs, charges, expenses in connection with preparation and submission and subsequent clarification of his tender in the event of withdrawal of the invitation of tenders by the Institute.
 - 26. The institute reserves the right to revise or amend the tender documents prior to the date notified for opening of the tenders and also the right to postpone the date of presentation and opening of tenders without assigning any reason, whatsoever.

- 27. The Director IISER, Mohali shall be referred as "Institute" in all the documents of Notice Inviting Tender/Contract Agreement.
- 28. Wherever the word 'Engineer-in –Charge occurs it shall mean Executive Engineer of IISER Mohali.

Condition of contract

- 1. The Contract means the documents forming the tender and acceptance thereof and the formal agreement executed between competent authority on behalf of the Director, IISER and the contractor, together with the document referred to therein including these conditions, the specifications, designs, drawings and instructions issued from time to time by Engineer-in-charge and all these documents taken together shall be deemed to form one contract and shall be complementary to one another.
- 2. In the contract, the following expressions shall, unless the context otherwise requires, have the meanings, hereby respectively assigned to them:-
- I) The expression works or work shall unless there be something either in the subject or context repugnant to such construction, be construed and taken to mean the works by or by virtue of the contract contracted to be executed whether temporary or permanent, and whether original, altered, substituted or additional.
- ii) The site shall mean the land/ or other places on into or through which work is to be executed under the contract or any adjacent land, path or street through which work is to be executed under the contract or any adjacent land, path or street which may be allotted or used for the purpose of carrying out the contract.
- iii) The contractor shall mean the individual, firm or company, whether incorporated or not, undertaking the works and shall include the legal personal representative of such individual or the persons composing such firm or company, or the successors of such firm or company and the permitted assignees of such, individual, firm or company.
- iv) The Institute means the Director, IISER and his successors.
- v) The Engineer-in-charge means the Executive Engineer who shall supervise and be in-charge of the work and who shall sign the contract on behalf of the Director, IISER Mohali mentioned in schedule 'F' hereunder.
- vi) Institute shall mean the Director IISER, Mohali.
- vii) Administration shall mean the administration of the IISER Mohali.
- viii) Local authority shall mean the municipal corporation of Mohali and shall also deemed to include any other body or department of the administration.
- ix) Accepting Authority shall mean the authority mentioned in Schedule 'F'

- x) Excepted Risk are risks due to riots (Other than those on account of contractor's employees) war (Whether declared or not) invasion, act of foreign enemies, hostilities, civil war, rebellion revolution, insurrection, military or usurped power, any acts of Institute damages from aircraft, act of God, such as earthquake, lightening and unprecedented floods, and other causes over which the contractor has no control and accepted as such by the Accepting Authority or causes solely due to use or occupation by the Institute of part of the works in respect of which a certificate of completion has been issued or a cause solely due to the Institute's faulty design of works.
- xi) Market Rate shall be the rate as decided by the Engineer-in-Charge on the basis of the cost of materials and labour at the site where the work is to be executed plus the percentage mentioned in Schedule 'F' to cover, all overheads and profits.
- xii) Schedule(s) referred to in these conditions shall mean the relevant
- schedule (s) annexed to the tender papers or the standard Schedule of Rates of the Institute mentioned in Schedule 'F' hereunder, with the amendments thereto issued upto the date of receipt of the tender.
- xiii) Department means Director, IISER or any Division of IISER which invites tenders on behalf of Institute as specified in the Schedule 'F'.
- xiv) Tendered value means the value of the entire work as stipulated in the letter of award.
- xv) Date of commencement of work: The date of commencement of work shall be the date of start as specified in schedule 'F' or the first date of handing over of the site, whichever is later, in accordance with the phasing if any, as indicated in the tender documents.

Scope

- 3. Where the context so requires, words imparting the singular only also include the plural and vice versa. Any reference to masculine gender shall whenever required include feminine gender and vice versa.
- 4.Headings and Marginal notes to these General Conditions of Contract shall not be deemed to form part thereof or be taken into considerations in the interpretation or construction thereof or of the contract.
- 5. The contractor shall be furnished, free of cost one certified copy of the contract documents except standard specifications, schedule of Rates and such other printed and published documents, together with all drawings as may be forming part of the tender papers. None of these documents shall be used for any purpose other than that of this contract.

Works to be Carried out:

6. The work to be carried out under the Contract shall, except as otherwise provided in these conditions, include all labour, materials, tools, plants, equipment and transport which may be required in preparation of and for and in the full and entire execution and completion of the works. The descriptions given in the Schedule of Quantities (Schedule-A) shall, unless otherwise stated, be held to include wastage on materials, carriage and cartage, carrying and return of empties, hoisting setting, fitting and fixing in position and all other labors necessary in and for the full and entire execution and completion of the work as aforesaid in accordance with good practice and recognized principles.

Sufficiency of Tender

- 7. The contractor shall be deemed to have satisfied himself before tendering as to the correctness and sufficiency of his tender for the works and of the rates and prices quoted in the Schedule of Quantities, which rates and prices shall except as otherwise provided, cover all his obligations under the Contract and all matters and things necessary for the proper completion and maintenance of the works.
- 8.2 If there are varying or conflicting provisions made in any one document forming part of the contract, the Accepting Authority shall be the deciding authority with regard to the intentions of the document and his decision shall be final and binding on the contractor.
- 8.3 Any error in description, quantity or rate in schedule of Quantities or any omission there from shall not vitiate the contract or release the Contractor from the execution of the whole or any part of the works comprised therein according to drawings and specifications or from any of his obligations under the contract.

Signing of

9. The successful tenderer/ contractor on acceptance of his tender by the

 - b) Safety Code.
 - c) Model Rules for the protection of health, sanitary arrangements for workers employed by the contractor.
 - d) Contractor's Labour Regulations.
 - e) List of Acts and omissions for which fines can be imposed.
- iii) No payment for the work done will be made unless contract is signed by the contractor.

Terms and conditions:

- 1. The contractor shall comply with the provisions of the Apprentices act 1961, minimum wages act 1938, Employers liability act, 1938 Maternity benefits Act 1961, Industrial disputes Act 1947, the Workmen Compensation Act, 1923 relevant laws and statutory requirements covered under various Labour Acts & Laws, Minimum Wages Act, Contract Labour (Regulation & Abolition) Act 1970, EPF, ESI etc. with regard to the personnel engaged by him for the said work as applicable and the rules and regulations issued there under and by the local Administration/ Authorities from time to time as well all provisions of Law applicable to workman. Failure to do so shall amount to breach of the contract and the Engineer-in-charge may at his discretion terminate the contract. The contractor shall also be liable for any pecuniary liability arising on account of violation by him of any of the said Acts and shall indemnify the Institute on that account and against all claims, damages or compensation thereof. Institute will not be liable for any act or omission on the part of the contractor in so far as any violation of any of the aforementioned Acts is concerned and will not be responsible in any way.
- 2. As it is mandatory for the Contractor to pay the prevailing minimum wages as fixed by Ministry of Labour & Employment, Govt. of India, plus the statutory dues like ESI, EPF, ELDI,GST etc., any bidder quoting less than the minimum wages and also not appropriately quoting for these charges shall be disqualified at the stage of evaluation. The rates as quoted above would be applicable for entire period of the contract and the contractor will not make any claim for additional charges under any circumstances unless any revision made by the appropriate Government Authority in the wages and statutory benefits. While quoting the rates, the contractor should keep in mind all these factors to avoid any type of dispute at any stage of the contract.

If for any reasons, the operator of next shift is unable to report or reach on duty, the operator manning the previous shift may be allowed to continue and his wages shall be regulated as per prevailing labour laws.

4. The operation of Substations (6 nos.)/Pumphouses (4 nos.)/STPs 4 nos.) shall be regulated as follows:-

- Sub Station 1 & Sub Station 2 (2 nos.)- To be manned round the clock in three shift operations by the same person as these sub stations are near to each other.

- Sub Station 4 (1 no.) To be manned in one shift operation (night).
- 66/11 KV Substation To be manned in one shift operation (night).
- Minimum manpower requirement (as per clause 5) for Substation operation: 8 nos.

b. Pump Houses:-

- There are four (04) pump houses, which are to be manned separately for two shift operations each.
- Minimum manpower requirement (as per clause 5) for pumphouse operation: 8 nos.

c. STP's:-

- STP East Gate and Hostel 6&8 (2 nos.) These two STPs, to be manned round the clock in three shift operations by the same person as these STP's are near to each other.
- STP residential area To be manned <u>separately</u> round the clock in three shift operations, as this STP is far off.
- STP IWD- To be manned in one shift operation (general shift).
- Minimum manpower requirement (as per clause 5) for STP operation: 6 nos.
- One (1) helper to be deputed in general shift for filling of DG oil, removal of scrap material, cleaning of trenches, etc

5. The Service Provider shall not employ any person below the age of 18 years. The service provider shall deploy his personnel with age limit between 18 to

- 6. The Service Provider shall provide onsite training for the deployed staff twice in a year at a gap of six months specifically for Technical Skills and to handle the situation in case of emergency.
- 7. The service provider shall provide required weekly off and leaves ass applicable and as per Govt. norms/labour laws.
- 8. Each shift shall be only for 08 hours, as per labour laws.
- 9. Any penalty imposed on the service provider shall not be passed on by him to his workers.
- 10. No any charges/fees shall be recovered/ charged from the deployed staff by the service provider on account of hiring/appointing, registration, bonds, security, administrative charges etc. If any complaint in this regard received in writing, the contract shall be rescinded and performance guarantee shall be forfeited.
- 11. Service Provider will provide a copy of job description to all workers on date of commencement of contract.
- 12. Each deployed staff shall not perform his duty more than 8 hours (One shift) in a day. On changing over the shift, the deployed staff on duty shall continue till next person joins.
- 13. In case a worker is reported missing from duty during his duty hours: service provider shall provide reliever in ½ an hour, failing which penalty @ Rs 1,000/- per shift shall be levied.
- 14. If the breakers, DG sets, pumps, STP plants are not operated within 10 minutes of tripping, then penalty @ Rs 500/- per hour shall be imposed, provided the fault is not of maintenance in nature.

In case of a worker deployed by the service provider suffers from sharp injury or any other injury requiring immediate treatment, the Service Provider shall ensure that worker receives the required treatment without any additional financial burden on the institute and the worker deployed. All liabilities arising out of any accident or death of staff while on duty shall be totally borne by the Service Provider.
- 18. The deployed staff by the successful bidder will not be the employee of IISER Mohali. The staff will not be entitled to avail any allowances/residential accommodation/facilities /benefits like Provident Fund, Pension, Gratuity, Medical Attendance Treatment etc. or any other benefits available to the Government Servants appointed on regular basis.
- 19. The workers of the Contractor shall not be the employees of the Institute in any manner and they shall not claim any wages or allowances, compensation, damages or anything arising out of their employment/duty under this contract. The contractor shall make them known about this position in writing before deployment under this agreement. The contract workers are the employees of the contractor and work under the supervision/control/discipline of the contractor/his representative. Moreover, the workers engaged by the contractor do not have any vested right for any regular employment in the Institute.
- 20. The agreement is for work on job basis and not for supply of contract labour. For all intents and purposes, the Agency shall be the "Employer" within the meaning of different Labour Legislations in respect of manpower so employed and deployed in this Institute for the said work. The persons deployed by the agency in the Institute shall not have claims of any Master and Servant relationship nor have any principal and agent relationship with or against IISER Mohali. The IISER Mohali shall not be under any obligation for providing employment to any of the worker of the Service

Provider after the expiry of the contract. The IISER Mohali does not recognize any employee employer relationship with any of the workers of the Service Provider.

- 21. The Service Provider shall not engage any sub Service Provider or transfer the contract to any person or firm.
- 22. As per guidelines of the Hon'ble Supreme Court of India no person will be allowed smoking in public place. The Service Provider will be responsible, if any, workers provided by him are found smoking in the Institute and he will be penalized in accordance with the rules.
- 23. The services of the deputed staff of the service provider can be taken anywhere in the institute as directed by the Engineer-in-charge.
- 24. That in the event of any loss occasioned to IISER Mohali as a result of any lapse on the part of the Service Provider or the persons employed/deputed by him and that would be established after an enquiry conducted by the IISER Mohali, the said loss may be claimed from the Service Provider up to the value of the loss. The decision of Director IISER Mohali in this regard will be final and binding on the Service Provider.
- 25. Any liability arising out of any litigation (including those in consumer courts) in any court due to any act of Service Provider's personnel shall be directly borne by the Service Provider including all compensation/ damage/ expenses/ fines. The Service Provider concerned personnel shall attend the court as and when required. All disputes subject to Mohali jurisdiction only.
- 26. The Service Provider shall have to obtain a license under the Contract Labour Regulations and Abolition Act 1970, from the Labour Commissioner, (Central), and Chandigarh within one month of execution of agreement. Failure to obtain license under the above said act may result in cancellation of contract and PG shall be forfeited.
- 27. After work done Complaint slip / feedback form should be signed by the complainant and the Service provider should maintain the record.
- 28. The list of staff alongwith proof of qualification, id proof,address proof, photograph etc going to be deployed shall be made available to the Engineer-in-charge and fresh list of staff shall be made available by the service provider after any change is made due to withdrawal of any incompetent person at the instance of the IISER Mohali or of his own by the service provider.

Payment of wages and penalty

- 29. The payment of wages should be made to the contractual employees through bank latest by 7th of every month failing which the contractor will be liable to be fined at the rates i.e. 1st week @ Rs.1000/- per day, 2nd week @ Rs.2000/- per day and 3rd week @ Rs.3000/- per day. The contract shall be rescinded thereafter and the performance guarantee shall be forfeited. He will also be responsible to comply with all legal provisions of relevant Acts in respect of payments and other statutory benefits as stated above. All payment to the workers shall be made through electronic banking system only in the respective bank account of personnel.
- 30. Payment will be released on monthly basis within 15 (Fifteen) working days from the date of receipt of bill complete in all respects and supported by the relevant documents such as attendance, Proof of payment of salaries like salary credit bank statement, proof of submission of statutory liabilities like EPF, ESI, Insurance premium, GST etc. and on certification by IWD of the Institute that the services provided during the month are satisfactory.
- 31. The Contractor shall also get the Saving Fund Accounts, ESI, EPF account etc of workers opened for the required workers and transfer their wages directly to these accounts. Wages are to be transferred into the accounts as declared by the staff. It is the contractor's liability to ensure that all staff deployed by him have such accounts from time to time.
- 32. The Institute will deduct TDS as applicable on the total bill as Income Tax as per provision of the Income Tax Act or any other applicable tax.
- 33. In case any employee of the contractor is absent from duty for any reason, the contract would provide substitute / replacement immediately, failing which the contractor shall be liable to pay the proportionate amount of wages to IISER Mohali which will be calculated on per day basis and shall be recovered from the monthly bill of the agency.

34. PERSONAL ACCIDENT INSURANCE:

The Contractor, as per Labour contract law shall cover his workers under insurance for personal accident and / or death while performing the duty in IISER

35. Report regarding annual inspection under section 7-A of EPF Act 1952 will be supplied by the agency at the end of every year indicating that all

- due has been deposited by the contractor failing which the security deposit retained by the Institute shall not be refunded.
- 36. If any money, as the result of any instructions from the Labour authorities or claim or application made under any of the Labour laws, or Regulation, be directed to be paid by the IISER Mohali, such money shall be deemed to be payable by the contractor to the 'Institute' within seven days. The Institute shall be entitled to recover the amount from the contractor by deduction from any money due to the contractor or from Performance Guarantee along with administrative/departmental charges.Performance guarantee shall be equivalent to one month wages of all manpower deployed or 5% value of contract whichever is higher.
- 37. In the event of default being made in the payment of any money in respect of wages/ESI/EPF etc of any person deployed by the contractor for carrying out this contract and if a claim therefore is filed in the office of the Labour Authorities and proof thereof is furnished to the satisfaction of the Labour Authorities, IISER Mohali may, failing payment of the said money by the contractor, make payment of such claim on behalf of the contractor to the said Labour Authorities and any sums so paid shall be recoverable by IISER Mohali from the contractor.
- 38. The contractor shall ensure full compliance with tax laws of India with regard to this contract and shall be solely responsible for the same. The contractor shall submit copies of acknowledgements evidencing filing of returns every year and shall keep the employer fully indemnified against liability of any tax, interest, penalty etc. of the contractor in respect thereof, which may arise.
- 39. The agency shall provide the Identity Cards to each worker deployed in the Institute carrying the photograph of the personnel and personal information as to name, date of birth, designation and Identification mark etc. free of cost and nothing extra shall be paid on this account. This has to be worn at all times by the persons engaged.

- 40. The Contractor has to display all the relevant information (wages/ ESI/ EPF/ Dispensary/Hospital etc.) for workers deployed in the Institute as required under the Law on important places as decided by the Institute.
- 41. The Engineer-in-charge at any time during contract period can ask the contractor to withdraw any incompetent person deployed by the contractor. The contractor shall deploy labour only after the approval of the concerned Engineer in charge and can be deputed anywhere in the Institute as required by the Engineer in charge. The list of staff deployed shall be made available to the Engineer-in-charge and fresh list of staff shall be made available by the contractor after any change is made due to withdrawal of any incompetent person at the instance of the Institute or of his own by the contractor.
- 42. IISER Mohali shall not be responsible for providing residential accommodation to the manpower provided by the contractor.
- 43. IISER Mohali shall not be under any obligation for providing employment to any of the worker of the contractor after the expiry of the contract.
- 44. The contractor shall not deploy the manpower with dubious records i.e. without character verification. The contractor will be entirely responsible for any mischief or wrong doing by any of the staff deployed by him.
- 45. The operation of substations shall be provided for 24 hours without any interruption by means of qualified and experienced manpower. Being essential services, during absentism of any employee, weekly off or gazetted holiday, the firm shall have to provide alternate manpower to provide uninterrupted operation.
- 46. The firm will be responsible for providing adequate staff for running of substations.

Minimum staff expected to be deployed for smooth operation of the substations, pump houses, STP's, etc is mentioned below. Contractor is expected to provide manpower accordingly.

- i) Minimum total staff required is as per clause 4 of Terms & Conditions.
- 47. The firm shall maintain proper log book for keeping record for the running of complete system. The log book should indicate for tripping of light, entire/or part of machinery/electrical equipment in operation as per direction of Engineer-in- charge which should be kept at proper place for inspection at all times.
- 48. The firm will be liable to maintain proper attendance record which shall be put up to the concerned Engineer in charge as and when required.
- 49. Any communication devices, if required, have to be provided by the contractor at his own cost to the deployed personnel.
- 50. The agency having valid ESI/EPF numbers are only eligible to apply.
- 51. The agency shall have to obtain Electrical/ HT LT licence and labour licence from Govt, after work is awarded to them within a month.
- 52. The decision of the Director, IISER, Mohali, regarding any disputes whatsoever arising out of the contract will be final and binding on the contractor.
- 53. All tools & stationery shall be provided by IISER Mohali.
- 54. In case of any defect occurs to any of the machine/part of the system during operation of the system or otherwise due to the negligence of the firm or persons deployed by him, the same shall have to be rectified by firm free of cost, otherwise cost would be recovered from the firm.

Duties and responsibilities:

A. Duties and Responsibilities of Substation operator:

- 1. Carry out operation of Substation equipment/DG sets etc.
- 2. Attend any breakdown/emergency anywhere in the building/substation, etc.
- 3. Carry out daily checks, etc.

B. Duties and Responsibilities of Pump House and STP operator:

- 1. Carry out operation of water circulation pumps, STPs etc.
- 2. Attend any breakdown/emergency call.

3. Carry out daily checks, etc.

C. Duties and Responsibilities of Helper:

1. Providing service of Helper as & where required to assist electrician/Substation attendant and Pump Operators for maintaining essential services.
