Tender shall be submitted by the Bidders in two parts:

(i) Technical Bid. – Cover I (ii) Financial Bid. - Cover II

The two bid system will be followed for this tender. In this system the bidder must submit bid on line at E-Procurement Portal(i.e. https://eprocure.gov.in/eprocure/app) his offer in two covers. "Cover No. I- Technical Bid along with requisite fee details and all forms under seal and signature of Bidder'' mentioned below and "Cover No.2 -Financial Bid" respectively.

The **Cove I** (Technical Bid) shall consist of following:

Earnest Money -The bidder shall furnish as part of its bid, an EMD of Rs. 37,000/-(Rupees thirty seven thousand only). The EMD is to be submitted through Demand Draft of any Scheduled / Nationalized Bank (drawn in favour of "Registrar, IISER, Mohali") or MSME certificate should be relevant to the work for which NIT called for.

NOTICE INVITING TENDER

1. Online item rate tenders are invited on behalf of the Director IISER Mohali from approved and eligible contractors of C.P.W.D. and those of appropriate list of Department Posts and Telecommunications, U.T. Administration, Chandigarh Housing Board, State PWD's, Autonomous body for the work of "AMC of fire alarm panels entailing detection and fire fighting system in various buildings at IISER Mohali"

The enlistment of the contractors should be valid on the last date of tenders.

In case only the last date of sale of tender is extended, the enlistment of contractor should be valid on the original date of sale of tenders.

In case both the last date of receipt of application and sale of tenders are extended, the enlistment of contractor should be valid on either of the two dates i.e. original date of sale of tender or on the extended date of sale of tenders.

1.1 The work is estimated to cost Rs.15,65,964/- Plus GST. This estimate, however, is given merely as a rough guide

1.1.1. The authority competent to approve NIT for the combined cost and belonging to the major discipline will consolidate NITs for calling the tenders. He will also nominate Division which will deal with all matters relating to the invitation of tenders.

For composite tender, besides indicating the combined estimated cost put to tender, should clearly indicates the estimated cost of each component separately. The eligibility of tenderer will correspond to the combined estimated cost of different components put to tender.

1.2 CRITERIA OF ELIGIBILITY

1.2.1 Bidder shall submit the EMD of Rs.37,000/- favoring Registrar, IISER Mohali and payable at Mohali.

NB- Original DD sends at Executive Engineer, IISER Mohali, Sector 81, Knowledge City, SAS Nagar, Mohali.

1.2.2. The tender shall be received by the undersigned by on 12.10.2021 up to 3:00 PM and envelope No. 1 only containing earnest money, conditions and tender documents shall be opened on the next working day. No consideration will be given to a tender received after the above stipulated time and date. Eligibility related documents shall be evaluated for criteria stipulated at 1.2.3 and agencies / contractors will accordingly be qualified/ disqualified by the competent Authority. The financial bid (Envelope No 2) of qualified tenderer shall then be opened at notified time, date. The rates of each item must be quoted in figures

1.2.3 Contractors who fulfill the following criteria shall be considered by IISER Mohali for technical evaluation (if required) and opening of commercial bids:

- I) Contractors /firms should have successfully completed directly during last 7 years ending last day of the month previous to the one in which the bidding are invited, either three similar works costing not less than 40% or two similar works costing not less than 50% or one similar work costing not less than 80 of the estimated cost of the work out of which at least one should have been executed in Govt departments. Relevant work orders for the work experience (alongwith completion certificate, as uploaded) may also be uploaded to make/distinguish the quantum of similar work executed by the contractor.
- II) Average annual financial turn over during the last 3 (three) years ending 31st March of the previous year should at least be 50% of the estimated cost of work.
- III) Not incurred loss in more than two years during the last five years ending 31st March of the previous year.
- IV) Work has to be carried out as per the guidelines for COVID-19 issued by MHA.
- V) Integrity pact as per attached

1.2.4 Eligibility criteria:

I/We undertake and confirm that eligible similar works(s) has/have not been got executed through another contractor on back to back basis. Further that, if such a violation comes to the notice of Department, then I/we shall be debarred for tendering in the Institute in future forever. Also, if such a violation comes to the notice of Department before date of start of work, the Engineer-in-Charge shall be free to forfeit the entire amount of Earnest Money Deposit/Performance Guarantee.

For the purpose of clause Similar work means "Work of AMC of fire alarm & detection system and/or fire hydrant system".

- 2. Agreement shall be drawn with the successful tenderer on General Conditions of Contract for works which is available from the Engineer-in-Charge. Tenderer shall quote their rates as per various terms and conditions of the said form which will form part of the agreement.
- 3. The time allowed for carrying out the work will be one year, which shall be extended for a further (1+1) years on mutually consent to be reckoned from the day of date of written order to commence the work from the date of start as defined in schedule 'F' or from the first date of handing over of the site, whichever is later, in accordance with the phasing, if any, indicated in the tender documents.
- 4. The site for the work is available

OR

The site for the work shall be made available in parts as specified below:-

- a. Tender document consisting of plans, specifications, the schedule of quantities of the various classes of work to be done and the set of terms & conditions of contract to be downloaded from website .
- 5. i) Tenders shall be accompanied with Earnest money of Rs.37,000/- by way of Receipt Treasury Challan/Deposit at Call receipt of a scheduled bank/fixed deposit receipt of a scheduled bank/demand draft of a scheduled bank issued in favour of the Registrar, IISER Mohali, Payable at Chandigarh. 50% of earnest money or Rs.20 lakh, whichever is less, will have to be deposited in the shape prescribed above and balance amount of earnest money can be accepted in the form of Bank guarantee issued by a scheduled bank having validity for 6 months or more from the last date of receipt of tenders
- 6. The contractor whose tender is accepted, will be required to furnish performance guarantee of 5% (Five Percent) of the tendered amount within the period specified in Schedule F. This guarantee shall be in the form of cash (in case guarantee amount is less than Rs.10000/-) or Deposit at Call receipt of any scheduled bank/Banker's cheque of any scheduled bank/Demand Draft of any scheduled bank/Pay order of any scheduled bank (in case guarantee amount is less than Rs.1,00,000/-) or Government Securities or Fixed Deposit Receipts or Guarantee Bonds of any Scheduled Bank or the State Bank of India in accordance with the prescribed form. In case the contractor fails to deposit the said performance guarantee within the period as indicated in Schedule 'F'. including the extended period if any, the Earnest Money deposited by the contractor shall be forfeited automatically without any notice to the contractor.

Tenderers are advised to inspect and examine the site and its surroundings and satisfy themselves before submitting their tenders as to the nature of the ground and sub-soil (so far as is practicable), the form and nature of the site, the means of access to the site, the accommodation they may require and in general shall themselves obtain all necessary information as to risks, contingencies and other circumstances which may influence or affect their tender. A tenderer shall be deemed to have full knowledge of the site whether he inspects it or not and no extra charge consequent on any misunderstanding or otherwise shall be allowed. The tenderer shall be responsible for arranging and maintaining at his own cost all materials, tools & plants, water, electricity access, facilities for workers and all other services required for executing the work unless otherwise specifically provided for in the contract documents and has made himself aware of the scope and specifications of the work to be done and of conditions and rates at which stores, tools and plant, etc. will be issued to him by the Institute and local conditions and other factors having a bearing on the execution of the work.

- 7. The competent authority does not bind itself to accept the lowest or any other tender and reserves to itself the authority to reject any or all the tenders received without the assignment of any reason. All tenders in which any of the prescribed condition is not fulfilled or any condition including that of conditional rebate is put forth by the tenderer shall be summarily rejected.
- 8. Canvassing whether directly or indirectly, in connection with tenders is strictly prohibited and the tenders submitted by the contractors who resort to canvassing will be liable to rejection.
- 9. The competent authority reserves to himself the right of accepting the whole or any part of the tender and the tenderer shall be bound to perform the same at the rate quoted.
- 10. The contractor shall not be permitted to tender for works in the Institute's Engineering Department (responsible for award and execution of contracts) in which his near relative is posted as Divisional Accountant or as an officer in any capacity between the grades of Executive Engineer and Junior Engineer (both inclusive). He shall also intimate the names of persons who are working with him in any capacity or are subsequently employed by him and who are near relative to any Group A & B officer in the Institute's Engineering Department. Any breach of this condition by the contractor would render him liable to be removed from the approved list of contractors of this Institute/debarring for further tendering in the Institute for at least 5 years.
- 11. No Engineer or other officers employed in Engineering or Administrative duties in Engineering Department of the Institute is allowed to work as a contractor for a period of one year after his retirement from Institute's service without the previous permission of the competent authority in writing. This contract is liable to be canceled if either the contractor or any of his employees is found at any time to be such a person who had not obtained the permission of the competent authority as aforesaid before submission of the tender or engagement in the contractor's service.

- 12. The tender for the works shall remain open for acceptance for a period of One hundred twenty (120) days from the date of opening of tenders/ One hundred twenty days from the date of opening of financial bid in case tenders are invited on 2/3 envelop system (strike out as the case may be) if any tenderer withdraws his tender before the said period or issue of letter of acceptance, whichever is earlier, or makes any modifications in the terms and conditions of the tender which are not acceptable to the department, then the Institute shall, without prejudice to any other right or remedy, be at liberty to forfeit 50% of the said earnest money as aforesaid. Further the tenderer shall not be allowed to participate in the re-tendering process of the work.
- 13. This Notice inviting tender shall form a part of the contract document. The successful tenderer/ contractor, on an acceptance of his tender by the Accepting Authority, shall within 15 days from the stipulated date of start of the work sign the contract consisting of:

a) The Notice Inviting Tender, all the documents including additional conditions, specifications and drawings, if any, forming the tender as issued at the time of invitation of tender and acceptance thereof together with any correspondence leading thereto.

b) Standard Form 7/8.

For Composite Tenders

16.1.1 The Engineer Incharge of the major component will call tenders for the composite work. The cost of tender document and Earnest Money will be fixed with respect to the combined estimated cost put to tender for the composite tender.

16.1.2 The tender document will include following three components:

Part A:- Form-6, Form-7/8 including schedule A to F for major component of the work, Standard General Conditions of Contract or latest edition as applicable with all amendments/modifications.

Part B:- General/specific conditions, specifications and schedule of quantities applicable to major component of the work.

Part C: Schedule A to F for minor component of the work. (Engineer in charge of major component shall also be competent authority under clause 2 and clause 5 as mentioned in schedule A to F for major components) General/specific conditions, specifications and schedule of quantities applicable to minor component(s) of the work.

16.1.3The tenderer must associate with himself, agencies of the appropriate class eligible to tender for each of the minor component individually.

The eligible tenderers shall quote rates in terms of overall percentage above or below the total estimated amount put to tender must be filled both in figures and words on the last page of schedule of quantities. It will be obligatory on the part of the tenderer to sign the tender document for all the components (The schedule of quantities, conditions and special conditions etc.)

16.1.5 After acceptance of the tender by competent authority, the Engineer in charge of major component of the work shall issue letter of award on behalf of the Director. After the work is awarded, the main contractor will have to enter into one agreement with Engineer in charge of major component and has also to sign two or more copies of agreement depending upon number of Engineer Incharge of minor components. One such signed set of agreement shall be handed over to Engineer in charge of minor component. Engineer Incharge of major component will operate part A and part B of the agreement. Engineer in charge of minor component(s) shall operate Part C along with Part A of the agreement.

16.1.6 Entire work under the scope of composite tender including major and all minor components shall be executed under one agreement.

16.1.7 Security Deposit will be worked out separately for each component corresponding to the estimated cost of the respective component of works. The Earnest Money will become part of the security deposit of the major components of work.

16.1.8 The main contractor has to associate agency(s) for minor component(s) conforming to eligibility criteria as defined in the tender document and has to submit detail of such agency(s) to Engineer-in-charge of minor component(s) within prescribed time. Name of the agency(s) to be associated shall be approved by Engineer-in-charge of minor component(s).

16.1.9 In case the main contractor intends to change any of the above agency/agencies during the operation of the contract, he shall obtain prior approval of Engineer-in-charge of minor component. The new agency/agencies shall also have to satisfy the laid down eligibility criteria. In case Engineer-in-charge is not satisfied with the performance of any agency, he can direct the contractor to change the agency executing such items of work and this shall be binding on the contractor.

16.1.10 The main contractor has to enter into agreement with the contractor(s) associated by him for execution of minor component(s). Copy of such agreement shall be submitted to Hospital Engineer in charge of each minor component as well as to Engineer in charge of major component. In case of change of associate contractor, the main contractor has to enter into agreement with the new contractor associated by him.

16.1.11 Running payment for the major component shall be made by Engineer-in-Charge of major discipline to the main contractor. Running payment for minor components shall be made by the Engineer-in-Charge of the discipline of minor component directly to the main contractor.

16.1.12 Final bill of whole work shall be finalized and paid by the Engineer-in-Charge of major component. Engineer(s) in charge of minor component(s) will prepare and pass the final bill for their component of work and pass on the same to the Engineer-in-Charge of major component for including in the final bill for composite contract.

16.1.13 It will be obligatory on the part of the tenderer to sign the tender document for all the components before the first payment is released.

No price preference to any corporate society/Registered society, Govt. Public Sector undertakings / bodies shall be given and tenders shall be exclusively dealt with on merit.

The contractor shall comply with the provisions of the Apprentices Act 1961, minimum wages Act 1948, Workmen's compensation Act 1923, contract labour (Regulation and Abolition Act 1970), payment of wages Act 1938, Employer's liability Act 1938, Maternity Benefits Act 1961, and the Industrial disputes Act 1947 as applicable and the rules and regulations issued there under and by the local Administration / Authorities from time to time as well all provisions of law applicable to workmen. Failure to do so shall amount to breach of the contract and the Engineer-in-Charge may at his discretion terminate the contract. The Contractor shall also be liable for any pecuniary liability arising on account of violation by him of any of the said Acts and shall indemnify the Institute on that account. Institute will not be liable for any act or omission on the part of the contractor in so far as any violation of any of the aforementioned acts.

Each tenderer shall submit only one tender; either by him or as partners in a joint venture. A tenderer who submits or participates in more than one tender will be disqualified.

Unless otherwise stated, the contract shall be for the whole work as described in the "Schedule of items of Works" and the drawings. The contractor shall be bound to complete the whole work as described in the schedule of items of works and the drawings, including additional items, if any, as per drawings and instructions. The issuance of certificate of completion as issued by the Engineer-in-Charge shall be mandatory and will be conclusive proof of completion of work.

The contractor shall get the appended structural drawing proof checked from structural Engineer before commissioning the work and hand over the design details to the Engineer-incharge.

Interpretations, corrections and changes to the Tenders Documents shall be made by Addendum, if required at E-Procurement portal on <u>https://eprocure.gov.in/eprocure/app</u>

Each Tenderer shall ascertain prior to submitting his Tender that he has received all Addenda issued and he shall so acknowledge their receipt in his Tender.

Bidder shall submit the documents in .pdf format:

i) Demand draft/Deposit at call receipt from a Scheduled Bank towards earnest money.

ii) Partnership deed or Registration Certificate of the Firm or Company as the case may be.

iii) Power of Attorney

The provisions in the Tender documents shall govern over the contents of the above paragraphs if in contradiction or variation.

The contractor shall comply with the provisions of prevalent ESI Act.

General Rules & Directions

General1. All works proposed for execution of contract will be notified in aRules &form of invitation to tender pasted in public places and signed by theDirectionsofficer inviting tender or by publication in Newspapers as the case
may be.

This form will state the work to be carried out, as well as the date for submitting and opening tenders and the time allowed for carrying out the work, also the amount of earnest money to be deposited with the tenderer, and the amount of the security deposit and performance guarantee to be deposited by the successful tenderer and the percentage, if any, to be deducted from bills: Copies of the specifications, designs and drawings and any other documents required in connection with the work signed for the purpose of identification by the officer inviting tender shall also be opened for inspection by the contractor at the officer inviting tender during office hours.

2. In the event of the tender being submitted by a firm, it must be singed separately by each partner thereof or in the event of the absence of any partner, it must be singed on his behalf by a person holding a power-of attorney authorizing him to do so, such power of attorney to be produced with the tender, and it must disclose that the firm is duly registered under the Indian Partnership Act, 1952.

3. Receipts for payment on account of work, when executed by a firm, must also be signed by all the partners, except where contractors are described in their tender as a firm, in which case the receipts must be signed in the name of the firm by one of the partners, or by some other person having due authority to give effectual receipts for the firm. 4. Any person who submits a tender shall fill up the usual printed form, stating at what rate he is willing to undertake each item of the work. Tenders, which propose any alteration in the work specified in the said form of invitation to tender, or in the time allowed for carrying out the work, or which contain any other conditions of any sort including conditional rebates will be summarily rejected. No single tender shall include more than one work, but contractors who wish to tender for two or more works shall submit separate tender for each. Tender shall have the name and number of the works to which they refer, written on the envelopes.

> The rate(s) must be quoted in decimal coinage. Amounts must be quoted in full rupees by ignoring fifty paise and considering more than fifty paise as rupee one.

Applicable for 4 A. In case of Percentage Rate Tenders, tenderer shall fill up the usual printed form, stating at what percentage below/above (in **Percentage Rate** figures as well as in words) the total estimated cost given in **Tender only** Schedule of Quantities at Schedule -A, he will be willing to (Form- 7) execute the work. The tenders submitted shall be treated as invalid if: (i) The contractor does not quote percentage above/below on the total amount of tender or any section/sub head of the tender. (ii) The percentage above/below is not quoted in figures & words both on the total amount of tender or any section/sub head of the tender. (iii) The percentage quoted above/below is different in figures & words on the total amount of tender or any section/sub head of the tender:-Tenders, which propose any alteration in the work specified in the said form of invitation to tender, or in the time allowed for carrying out the work, or which contain any other conditions of any sort including conditional rebates, will be summarily rejected. No single tender shall include more than one work, but contractors who wish to tender for two or more works shall submit separate tender for each. Tender shall have the name and number of the works to which they refer, written on the envelopes.

Application for item Rate Tender only (Form– 8) 4B. In case the lowest tendered amount (estimated cost + amount worked on the basis of percentage above/below) of two or more contractors is same, such lowest contractors will be asked to submit sealed revised offer in the form of letter mentioning percentage above/below on estimated cost of tender including all sub sections/sub heads as the case may be, but the revised percentage quoted above/below on tendered cost or on each sub section/sub head should not be higher than the percentage quoted at the time of submission of tender. The lowest tender shall be decided on the basis of revised offers.

In case any of such contractor refuses to submit revised offer, then it shall be treated as withdrawal of his tender before acceptance and 50% of earnest money shall be forfeited.

If the revised tendered amount of two or more contractors received in revised offer is again found to be equal, the lowest tender, among such contractors, shall be decided by draw of lots in the presence of Engineer-in-charge of major & minor component(s) (also Director, IISER in case Horticulture work is also included in the tender).

In case all the lowest contractors those have quoted same tendered amount, refuse to submit revised offers, then tenders are to be recalled after forfeiting 50% of EMD of each contractor.

Contractor(s), whose earnest money is forfeited because of non-submission of revised offer, shall not be allowed to participate in the re-tendering process of the work.

5. The officer inviting tender or his duly authorized assistant will open tenders in the presence of any intending contractors who may be present at the time, and will enter the amounts of the several tenders in a comparative statement in a suitable form. In the event of a tender being accepted, a receipt for the earnest money shall thereupon be given to the contractor who shall thereupon for the purpose of identification sign copies of the specifications and other documents mentioned in Rule-I. In the event of a tender being rejected, the earnest money shall thereupon be returned to the contractor remitting the same, without any interest.

6. The officer inviting tenders shall have the right of rejecting all or any of the tenders and will not be bound to accept the lowest or any other tender.

7. The receipt of an accountant or clerk for any money paid by the contractor will not be considered as any acknowledgment or payment to the officer inviting tender and the contractors shall be responsible for seeing that he procures a receipt signed by the officer inviting tender or a duly authorized Cashier.

8. The memorandum of work tendered for and the schedule of materials to be supplied by the department and their issue-rates, shall be filled and completed in the office of the officer inviting tender before the tender form is issued. If a form is issued to an intending tenderer without having been so filled in and incomplete, he shall request the officer to have this done before he completes and delivers his tender.

9. The tenderer shall sign a declaration under the officials Secret Act 1923, for maintaining secrecy of the tender documents drawings or other records connected with the work given to them. The unsuccessful tenderer shall return all the drawings given to them.

9A. Use of correcting fluid, anywhere in tender document is not permitted. Such tender is liable for rejection.

Applicable for 10 In the case of Item Rate Tenders, only rates quoted shall be **Item Rate** considered. Any tender containing percentage below/above the rates quoted is liable to be rejected. Rates quoted by the **Tender only** contractor in item rates tender in figures and words shall be (Form- 8) accurately filled in so that there is no discrepancy in the rates written in figures and words. However, if a discrepancy is found, the rates which correspond with the amount worked out by the contractor shall unless otherwise proved be taken as correct. If the amount of an item is not worked out by the contractor or it does not correspond with the rates written either in figures or in words then the rates quoted by the contractor in words shall be taken as correct. Where the rates quoted by the contractor in figures and in words tally but the amount is not worked out correctly, the rates quoted by the contractor will unless otherwise proved be taken as correct and not the amount. In even no rate has been quoted for any item(s), leaving space both in figure(s), word(s) and amount blank, it will be presumed that the contractor has included the cost of this/these item(s) in other items and rate for such item(s) will be considered as zero and work will be required to be executed accordingly.

Applicable for Percentage Rate Tender only (Form- 7)

10A. In case of Percentage Rate Tenders only percentage quoted shall be considered. Any tender containing item rates is liable to be rejected. Percentage quoted by the contractor in percentage rate tender shall be accurately filled in figures and words, so that there is no discrepancy.

11. In the case of any tender where unit rate of any item/items appear unrealistic, such tenders will be considered as unbalanced and in case the tenderer is unable to provide satisfactory explanation such a tender is liable to be disqualified and rejected.

12. All rates shall be quoted on the tender form. The amount for **Item Rate** each item should be worked out and requisite totals given. **Tender only** Special care should be taken to write the rates in figures as well as in words and the amount in figures only, in such a way that (Form- 8) interpolation is not possible. The total amount should be written both in figures and in words. In case of figures, the word 'Rs.' should be written before the figure of rupees and word 'P' after the decimal figures, e.g. 'Rs. 2.15 P' and in case of words, the word, 'Rupees' should precede and the word 'Paise' should be written at the end. Unless the rate is in whole rupees and followed by the word 'only' should invariably be upto two decimal places. The Security deposit will be collected by deductions from the running bills of the contractor at the rates mentioned above and the earnest money deposited at the time of tenders, will be treated as a part of the Security Deposit. The Security amount will also be accepted in the shape of Government Securities. Fixed Deposit Receipt of a Scheduled Bank or State Bank of India will also be accepted for this purpose provided confirmatory advice is enclosed.

14. On acceptance of the tender, the name of the accredited representative(s) of the contractor who would be responsible for taking instructions from Engineer-in-Charge shall be communicated in writing to the Engineer-in-Charge.

15. Turnover tax, GST or any other tax on material in respect of this contract shall be payable by the Contractor and the Institute will not entertain any claim whatsoever in respect of the same.

16. The contractor shall give a list of employees in IISER related to him.

17. The tender for the work shall not be witnessed by a contractor or contractors who himself/themselves has/have tendered or who may and has/have tendered for the same work. Failure to observe this condition would render, tenders of the contractors tendering, as well as witnessing the tender, liable to summary rejection.

18. The tender for composite work includes in addition to building work all other works such as sanitary and water supply installations drainage installation, electrical work, horticulture work, roads and path etc. The tenderer apart from being a registered contractor (B & R) of appropriate class, must associate himself with agencies of appropriate class which are eligible to tender for sanitary and water supply drainage, electrical and horticulture work in a composite tender subject to the approval of the institute.

20. The contractor shall comply with the provisions of the Apprentices Act 1961, and the rules and orders issued there under from time to time. If he fails to do so, his failure will be a breach of the contract and the Engineer Incharge may in his discretion without prejudice to any other right or remedy available in law cancel the contract. The contractor shall also be liable for any pecuniary liability arising on account of any violation by him of the provisions of the said Act.

23. Every tender shall be written in the English language. All other information such as documents and drawings supplied by the tenderer will also be in the English language only. Drawings and designs shall be dimensioned according to the metric system of measurements. Tenders shall be forwarded under cover or a letter typewritten on the tenderer's letterhead and duly signed by the tenderer. Signature must be in long hand executed in ink by a duly authorized principal of the tendering firm. No oral, telegraphic or telephonic tenders or subsequent modifications there to shall be entertained.

24. The tenderer shall sign of every page of the tender documents in taken of acceptance of tender conditions and for the purpose of identification. Tenders containing erasures and alterations of the tender documents are liable to the rejected unless these are authenticated by the person signing the Tender Documents.

28. Wherever the word 'Engineer-in –Charge occurs it shall mean Executive Engineer of IISER Mohali.

Condition of contract

vi) Institute shall mean the Director IISER, Mohali.

vii) Administration shall mean the administration of the IISER Mohali.

xiii) Department means Director, IISER or any Division of IISER which invites tenders on behalf of Institute as specified in the Schedule 'F'.

xiv) Tendered value means the value of the entire work as stipulated in the letter of award.

xv) Date of commencement of work: The date of commencement of work shall be the date of start as specified in schedule 'F' or the first date of handing over of the site, whichever is later, in accordance with the phasing if any, as indicated in the tender documents.

Instructions for Online Bid Submission:

The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal.

More information useful for submitting online bids on the CPP Portal may be obtained at: <u>https://eprocure.gov.in/eprocure/app.</u>

REGISTRATION

- 1) Bidders are required to enroll en the e-Procurement module of the Central Public Procurement (<u>https://eprocure.gov.in/eprocure/app</u>) by clicking on the link "Online bidder :Enrollment" on the CPP Portal which is free of charge.
- 2) As part of the enrolment process, the bidders will be required to choose a unique username as assign a password for their accounts.
- 3) Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- 4) Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class II or Class III Certificates with Signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / nCode / eMudhra etc.), with their profile.
- 5) Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC's to others which may lead to misuse.
- 6) Bidder then logs in to the site through the secured log-in by entering their user ID / password and the password of the DSC /e-Token.

SEARCH FOR TENDER DOCUMENTS

- There are various search option built in the CPP Portal, to facilitate bidders to search active tenders by several parameters. These parameters could include Tender ID, Organization Name, Location, Date, Value, etc. There is also an option of advanced search for tenders, wherein the bidders may combine a number of search parameters such as Organization Name, Form of Contract, Location, Date, Other keywords etc. to search for a tender published on the CPP Portal.
- 1) Once the bidders having selected the tenders they are interested in, they may download the required documents / tender schedules. The tenders can be moved to the respective 'My Tenders' folder. This would enable the CPP Portal to intimate the bidders through SMS / e-mail in case there is any corrigendum issued to the tender document.
- 2) The bidder should make a note of the unique Tender ID assigned to each tender, in case they want to obtain any clarification I help from the Helpdesk.

PREPARATION OF BIDS

- 1) Bidder should take into account any corrigendum published on the tender document before submitting their bids.
- 2) Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid. Please note the number of covers in which the bid documents have to be submitted, the number of documents including the names and content of each of the document that need to be submitted. Any deviations horn these may be to rejection of the bid.
- 3) Bidder, in advance, should get ready the bid documents to be' submitted as indicated in the tender document / schedule and generally, they can be in PDF / XLS / RAR / DWF / JPG formats. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.
- 4) To avoid the time and effort required in uploading the same set of standard documents which are required to be submitted as a part of every bid, a provision of uploading such standard documents (e.g. PAN card copy, annual reports, auditor certificates etc.) has been provided to the bidders. Bidders can use "My Space" or {father Important Documents' area available to them to upload such documents. These documents may be directly submitted from the "My Space" area while submitting (;I bid, and need not be uploaded again and again. This will lead to a reduction in the time required for bid submission process.

SUBMISSION OF BIDS

- 1. Bidder should log into the site well in advance for bid submission so that they can upload the bid in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other issues.
- 2 The bidder has to digitally sign and upload the required bid documents one by erne as indicated in the tender document.
- 3 Bidder has to select the payment option as "offline" to pay the tender fee / EMD as applicable and enter details of the instrument,
- 4 Bidder should prepare the EMD as per the instructions specified in the tender document. The original should be posted/couriered/given in person to the concerned official, latest by the last date of bid submission or as specified in the tender documents. The details of the DO/any other accepted instrument, physically sent *r* should tally with the details available in the scanned copy and the data entered during bid submission time. Otherwise the uploaded bid will be rejected.
- 5. Bidders are requested to note that they should necessarily submit their financial bids in the format provided and no other format is acceptable. If the price bid has been given as a standard BoQ format with the tender document, then the same is to be downloaded and to be filled by all the bidders. Bidders are required to download the BoQ file, open it and complete the white coloured (unprotected) cells with their respective financial quotes and other details (such as name of the bidder). No other cells should be changed. Once the details have been completed, the bidder should save it and submit it online, without changing the filename. If the BoQ file is found to be modified by the bidder, the bid will be rejected.

a) Submission of a tender by a tenderer implies that he has read all the stipulations contained in this tender document and all other contract documents and has acquainted himself of the nature, site conditions scope and specifications of the works to be executed and of conditions and rates at which stores will be issued to him by the IISER. The contractor shall also be deemed to have acquainted himself will local conditions and other factors which have a bearing on the execution of the works.

b) Before submitting the tender for the work to IISER, the tenderer should thoroughly examine the existing conditions of site

c)After award of the work contractor has to prepare and submit the shop drawings (only for airconditioning / fabrication work) for approval of the Engineer-in-charge.

d)No claim will be entertained on account of ignorance of site conditions.

AMC OF FIRE ALARM SYSTEM

SCOPE OF MAINTENANCE:

PART-I

- 1. To ensure that complete fire detection system is always clean and in healthy working condition.
- 2. Perform checks as mentioned in the tender document.
- 3. To perform tasks subsequent to a real alarm situation.

PART-II(TASKS TO BE PERFORMED WITHIN 15 DAYS)

1. Familiarize the maintenance personnel with the Fire detection and alarm system and their responsibility in consultation with maintenance in charge.

2. Inspect the complete system for proper functioning. Any shortcoming noticed should be recorded and brought to the notice of engineer-in-charge.

- 3. Carry out detector cleaning wherever required and zone testing.
- 4. Educate maintenance personnel regarding steps to be taken in case of fire.

PART-III (MAINTENANCE SCHEDULE TO BE FOLLOWED)

1. Check working of PA system.

- 2. Check working of F/D system from the control panel.
- 3. Check battery for proper charge, water level & clean contacts .

4. The Contractor shall replace the defective set of batteries, fire detectors, MCP etc or any other damaged/non working part whenever required after informing the Engineer incharge and getting the necessary permission. The same shall be on free or chargeable basis separately to IISERM as mentioned below.

5. The Contractor shall be required to demonstrate the working of the Fire alarm and detection system to educate the campus residents /building users whenever asked to do so.

- 6. Cleaning of Smoke / Heat detectors whenever required for good performance.
- 7. Testing by generating smoke or heat to check the sensitivity of the detectors.
- 8. Testing of fire alarm hooters by operating them from penal & by operating detectors.
- 9. Testing of Manual Call Points by operating.
- 10. Testing of PA system for working condition.
- 11. Testing the sub fire alarm control penal & main control penal.
- 12. Testing of batteries performance for the fire alarm control penal.
- 13. Testing of wiring from each detector/MCP/Hooter from penal.
- 14. Maintenance of the system if it's not in working.
- 15. Training to the staff that how to operate the fire alarm system in any emergency condition.

16. Checking the whole fire alarm system for the parts already installed are fitted at their location or missing.

17. The complete performance report of each & individual penal will be provided for the system every quarter.

18. Check for all any damage of Physical Parts i.e. Glass, Switch Hammer etc in MCP.

- 19. Check for Manual Call Point Functioning
- 20. Check for Hooter Sound.
- 21. Panel Inspection for Intact and Continuous Power Supply.
- 22. All zones working properly or not.
- 23. All Cards are in working condition or not.

01) Fire Hydrant Point.

- A. Check up the Wheel.

- C. Check up gland nut.
- D. Check up the Blank Cap.
- E. Check up the Orifice of the female couplings.
- F. Check up the Box, Hose Box Glass, Bidding and Key
- G. Check up the Hose for any Pin Holes or Damages
- H. Check up the Hose Male & Female Coupling.
- I. Check up the Branch Pipe.
- J. Oiling Greasing of Wheel, Hinges of Hose Boxes

02) Hose Reel.

- A. Check for Hose reel Movement.
- B. Check rubber hose for Hardness
- C. Check shutt-off Nozzle
- D. Check Ball Valve Connection
- E. Oil ,Greasing of All Rotary Parts F. Cleaning of Rubber Hose

03) <u>Pumps.</u>

- A. Check for Leakages in Gland
- B. Start Motor to confirm Fitness of Pump as well as proper power supply.
- C. Clean Panel for Accumulation of Carbon.
- D. Check for any Loose contacts in Cable Connections
- E. Check System operating in Auto Mode
- F. Check for Proper Pressure being maintained
- G.Check for Proper Connections from Overhead Tank
- H. Check Proper Functioning of Valves
- I. Check for Proper Electric Connections to Starter Panel
- J. Check Air Release Valves for Proper Functioning.

04) Sprinklers.

- A. Check Sprinklers for damage
- B. Check Leakages due to improper Fittings.
- C. Check Alarm Gong for proper functioning.

05) Piping and Valves

- A. Check for leakages in Pipes and Valves
- B. Check Proper Functioning of Valves
- C. Oiling and Greasing of Valves

• Major Faults and repairs in Pump and Motor to be attended and are payable separately.

PART-II (GENERAL PRACTICES IN FIRE HYDRANT SYSTEM TO BE FOLLOWED) :

1. The agency shall have to operate Fire hydrant system every fortnightly minimum, including servicing and attend to faults under the scope of AMC.

2. Inspection of the system has to be carried out daily covering small areas everyday.

3. Any abnormality/leakage must be addressed immediately and also to be reported to IISER engineering department.

4. Oiling and greasing to be carried out on a regular basis as and when required.

5. The agency shall have to maintain log book, repair record and service reports and shall produce when asked for.

6. As per the norms, minimum water pressure must be maintained in the hydrant line.

7. Piping system, valves, hose pipes, hose reels, sprinklers etc shall be checked periodically and its proper record to be maintained.

8. Defective piping system, valves, hose pipes, hose reels, sprinklers etc shall be repaired or replaced as required after informing IISER engineering department.

9. The agency shall check electrical motors and pumps periodically and defect if any should be addressed immediately.

10. The agency shall check the fire hydrant electrical control panel, wiring, motor connections and all other fire fighting related electrical system in pump houses and any abnormality found must be addressed immediately.

11. Minor painting work to be done on rusted parts at agency's own cost.

12. The entire fire hydrant system of the campus must be fully operational and ready for fire fighting at all times. The agency should ensure its compliance at all times.

NOTE:-

1. The methodology is to be worked out in consultation with Engineer-in-charge as the same may vary according to different systems installed.

2. The firm has to demonstrate to the Maintenance-in-charge proper working of the entire fire alarm, detection and fire hydrant system whenever asked for. Deficiencies if any noticed during demonstration shall be attended within a week's time.

3. In case of any fire alarm, true or false, or in case of any other fault or problem in the fire alarm & hydrant system it is expected that the maintenance person has to attend the same within one day of receiving the complaint in consultation with Engineer in charge and kept on record.

4. Inspection of fire system to be conducted atleast once in quarter or as deemed necessary, by the engineer of concerned OEM (to be called by the AMC agency) for identifying defects and solutions and carrying out the necessary rectification work/ repairs/ replacement or new part installation. OEM engineer visit is payable separately to the agency as per the rated quoted by him.

PART-IV(MATERIALS)

1. All material is to be arranged by the contractor. Materials included/excluded in the scope of work are mentioned below.

2. All material supplied and used on the work shall be got approved from the Engineer in charge or his authorized representative before using on the site. The rejected/dismantled material should be immediately handed over to the Engineer in charge or his authorized representative immediately on work completion.

3. Labour charges to be incurred in material fixing shall be borne by the contractor and are covered

under scope of AMC, unless otherwise mentioned. Labour for fire hydrant pipes related repair/rectification work, major overhauling or repair is payable separately.

PART-V(SPECIAL CONDITIONS RELEVANT TO PARTICULAR JOB/PARTICULAR STAFF)

1. Any minor addition/alteration during the period of contract shall also be maintained by the firm and nothing extra shall be payable on this account.

2. Failure of system to activate in the event of smoke/fire will invite suitable action and penalty as mentioned shall be levied.

3. No part of the system should be swapped/transferred/relocated or taken out of the Institute without prior permission/gate pass from the Engineer in charge.

PART- VI (INCLUSIONS/EXCLUSIONS)

Inclusions :

1. All consumables in are included in the scope of contract like cleaning cloth/equipment, nuts, bolts, screws, grease, lamps, gland dori, oil, fuses etc.

- 2. Calibration/resetting of fire detectors.
- 3. Minor software up gradation whenever required.
- 4. Minor cable connections.

5. Minor repair work involving small components only.

6. Any physical damage to any part of the system/replacement by the contractor's workers will be on chargeable basis to the contractor.

Exclusions :

1. Replacement/addition of hardware like PCBs, cards, Fire/smoke/heat detectors, MCP, Hooters, Speakers, panel, glass cover/box etc.

2. Major Software up-gradation, re-programming, re-formatting.

3. Installation of antivirus software.

- 4. Repair/replacement of UPS, Power supply, power pack, batteries.
- 5. Major expansion/addition of fire alarm and detection equipment.

6. Any physical damage to any part of the system/replacement by the Institute will be on chargeable basis to IISERM.

7. Damage done to equipment due to rains, floods, fire, accident, riot, breakages, vandalism, pest, misuse, theft.

8. Defects/ repairs resulting from servicing/ repairs done by a person other than the contractor's authorised technician.

9. Defects in the system arising out of structural/environmental changes/ variation.

All excluded items as per annexure C are on chargeable basis to IISER Mohali whose rates are to be quoted separately.

TERMINATION OF CONTRACT:

1. Right is reserved by IISERM for terminating the contract by giving one week's notice due to serious default. This includes major break down or accident due to negligence on the part of firm, failure to attend breakdown, disobedience and abandoning the site etc. In such a case full performance guarantee shall be forfeited by IISERM. The decision of Executive Engineer in this regard shall be final and binding.

2. Right is reserved by IISERM for closure of the contract at any time by giving one month notice for reasons not attributed to the firm. The decision of Executive Engineer shall be final and binding on the contractor for closure of contract and for which contractor shall not have any claim on account of pre closure.

GENERAL CONDITIONS :

1. There shall be minimum five visits every quarter by the firm for fire alarm systems wherein it should ensure that all the systems are in good working condition by carrying out inspection of control panels and detection equipment. If not, then corrective action should be taken immediately by the firm. Breakdown calls shall be unlimited.

2. The agency shall deploy one technician on daily basis visit to the campus for checking and testing of all detection and hydrant system. His job will be to carry out regular inspection and repair of fire hydrant and alarm systems in all buildings and open areas of the campus and ensure its serviceability at all times. They shall also organise fire drill whenever asked for and also assist in fire fighting whenever a fire incident happens. Hence, the contractor should ensure that the persons deployed by him are fully trained to handle such jobs.

3. The contractor shall comply with the provisions of statutory acts as applicable and notified by Government of India from time to time. Failure to do so shall amount to breach of the contract and the Engineer-in-charge may at his discretion terminate the contract. The contractor shall also be liable for any pecuniary liability arising on account of violation by him of any of the said Acts and shall indemnify the Institute on that account and against all claims, damages or compensation thereof. Institute will not be liable for any act or omission on the part of the contractor in so far as any violation of any of the aforementioned Acts is concerned and will not be responsible in any way.

1. Any penalty imposed on the service provider shall not be passed on by him to his workers.

2. No any charges/fees shall be recovered/ charged from the deployed staff by the service provider on account of hiring/appointing, registration, bonds, security, administrative charges etc. If any complaint in this regard received in writing, the contract shall be rescinded and performance guarantee shall be forfeited.

3. If any worker of the contractor indulges himself in any misconduct and causes loss to IISER Mohali, he should be shifted immediately by the contractor from the Institute.

4. If any damage is caused by the workers deployed by the firm to any part or equipment which is IISER's property, then contractor should repair or replace it free of cost. In case of any damage due to mishandling of the installation, recovery shall be made from the bill/performance guarantee.

- 5. It is contractor's responsibility that all personnel deployed by him are free from Covid-19 or any other disease. Any vaccination/treatment will be contractor's liability. Compliance report in this regard may be furnished to the Engineer-in-charge on demand.
- 6. In case of a worker deployed by the service provider suffers from sharp injury or any other injury during deployment at IISER Mohali requiring immediate treatment, the contractor shall ensure that worker receives the required treatment without any additional financial burden on the institute and the worker deployed. All liabilities arising out of any accident, injury or death of staff while on duty shall be totally borne by the Service Provider. It will be responsibility of the contractor to have Accident Insurance Policy of its staff to cover accidental risks as per Workmen's compensation act.
- 7. The workers of the Contractor shall not be the employees of the Institute in any manner and they shall not claim any wages or allowances, compensation, damages or anything arising out of their employment/duty under the agency. The contract workers are the employees of the contractor and work under the supervision/control/ discipline of the contractor/his representative. Moreover, the workers engaged by the contractor do not have any vested right for any regular employment in the Institute.

8. The Service Provider shall not engage any sub Service Provider or transfer the contract to any person or firm.

9. As per guidelines of the Hon'ble Supreme Court of India no person will be allowed smoking in public place. The Service Provider will be responsible, if any, workers provided by him are found smoking in the Institute and he will be penalized in accordance with the rules.

10. That in the event of any loss occasioned to IISER Mohali as a result of any lapse on the part of the contractor or the persons employed/deputed by him and that would be established after an enquiry conducted by the IISER Mohali, the said loss may be claimed from the Service Provider up to the value of the loss. The decision of Director IISER Mohali in this regard will be final and binding on the contractor.

11. Any liability arising out of any litigation (including those in consumer courts) in any court due to any act of Service Provider's personnel shall be directly borne by the Service Provider including all compensation/ damage/ expenses/ fines. The Service Provider concerned personnel shall attend the court as and when required. All disputes subject to Mohali jurisdiction only.

12. The contractor shall not deploy the manpower with dubious records i.e. without character verification. The contractor will be entirely responsible for any mischief or wrong doing by any of the staff deployed by him.

13. All stationery shall be provided by IISER Mohali. However, the contractor should provide proper tool kit to the persons deployed.

14. Record of preventive maintenance and testing of equipment etc. carried out has to be readily available at site, failing which firm shall be liable of non-execution of its liability under contract. If felt necessary Engineer-in-Charge has power to modify preventive / testing schedule. A proper register/job sheet should be maintained having all records of maintenance etc.

18. The agency has to supply details of all the workers (Name, and address etc.) engaged by him and get it approved by the Executive Engineer before deployment at site. Any staff deployed without approval & entry in register shall be treated as poor performance on the part of agency.

19. Firm should provide a round the clock helpline contact telephone number. In case of an emergency, contractor and authorized engineer/ supervisor shall be made available at site on short notice from engineer in charge and make all efforts to make the situation normal at the earliest.

20. Shut down for maintenance shall be taken with prior approval of the department.

21. The workers engaged by firm should maintain proper discipline and good behaviour with occupants. The firm shall remove such workers from the site whose behaviour is found improper. Executive Engineer's decision in this regard shall be final.

22. Agency has to observe all the labour rules and regulations in-force. ESI, EPF and all other workers related liabilities shall be the sole responsibility of the contractor. Any defaults in such liabilities shall be the sole responsibility of the contractor and IISER Mohali shall not entertain any communication or claim from the relevant Government authorities.

23. No equipment should be un-mounted and taken out from the Institute without a proper Gate Pass issued by the Engineer In charge.

24. The Contractor shall make his own arrangement at his own cost for electrical/general tools and laptop or any other equipment required for testing and repairing of the system. The

workers/technicians must be in possession of such tools etc at all times.

25. No accommodation to the workers shall be provided by the Institute.

26. The contractor or his workers shall not misuse the premises allotted to them for any purpose other than for which the contract is awarded.

27. Cleaning of the premises, floor etc after work completion will be the responsibility of the agency.

28. The contractor has to deploy more manpower, if required, for attending breakdown and completing breakdown work in minimum possible time for which no extra payment would be made.

29. In case any shortage of equipment or need of additional equipment/s is felt by the firm then the same should be brought to the notice of the engineer in charge and can be installed after obtaining the necessary permission, on chargeable basis.

30. In case any shutdown is required for carrying out the AMC work, then the same should be informed to the Engineer in charge well before hand and a shutdown should be carried out only after obtaining the necessary approval.

31. Any displacement, relocation of the Fire Detection equipment should be avoided by the firm.

32. All necessary drawings, manuals etc will be provided to the firm on demand.

33. The firm should finish the work in stipulated time. Any extra labour incurred in meeting the work deadlines shall not be chargeable and will be the firm's liability.

34. AMC charges will be payable quarterly after satisfactory completion of work and certification by Engineer in Charge, upon production of the quarterly bill.

20. The annual maintenance contract rates will be same for one year which can be extended for a further period of 1+1 years on satisfactory performance by the agency and as mutually agreed.

21. The contractor shall comply with all statutory requirements in respect of said work.

22. The quantities as mentioned in this order can be increased or decreased as per the requirement of work.

23. All urgent calls and complaints should be attended within 3 hours.

24. The company's attending technicians should be well trained to handle all the works. The Institute will not be responsible for any physical or personal damage to the company's technician while carrying out the AMC work.

25. All the company's attending technicians should take all necessary precautions while carrying out the AMC work. No compromise on safety should be allowed.

25. Carrying out liasoning with OEMs of individual equipments will be the sole responsibility of the agency. However, in case of any delay in repair etc. by the OEM, the agency should keep the Engineer in charge well informed from time to time.

26. All hidden work shall be carried out in the presence of Engineer in charge or his authorized representative.

27. The Contractor shall provide, update and maintain any software that may be required during currency of the contract.

28. The Contractor must have a valid authorisation certificate from M/s Edwards as majority of panels

are from this firm. The certificate must be valid at all times during currency of the contract. 29. The firm should carefully read and consider the list of fire alarm panels/hydrants installed in various buildings to get an idea of scope of work while quoting charges of AMC. Site visit may also be carried out for the same.

PENALTY:

In case a worker is reported missing from duty during his duty hours, the agency shall provide replacement within ½ an hour, failing which penalty @ Rs 1,000/- per shift shall be levied.
 If the fire alarm system or fire hydrant system fails to operate after being declared 'fit' by the agency, penalty @ Rs. 5000 per occasion shall be levied.
