SUBMISSION OF TENDER:

Tender shall be submitted by the Bidders in two parts:

(i) Technical Bid. – Cover I (ii) Financial Bid. - Cover II

The two bid system will be followed for this tender. In this system the bidder must submit bid on line at E-Procurement Portal(i.e. https://eprocure.gov.in/eprocure/app) his offer in two covers. "Cover No. 1-Technical Bid along with requisite fee details and all forms under seal and

signature of Bidder" mentioned below and "Cover No.2 - Financial Bid"

respectively.

The Cover I (Technical Bid) shall consist of following:

Earnest Money -The bidder shall furnish as part of its bid, an EMD of Rs.12,000.00/- (Rupees Twelve thousand only). The EMD is to be submitted through Demand Draft of any Scheduled/ Nationalized Bank (drawn in favour of "Registrar, IISER, Mohali") or MSME certificate should be relevant to the work for which E-Tender/EOI has been called. Payable at Mohali

Scope of work:

The firm has to conduct energy audit of the campus spread over a land of 125 Acres as per the scope mentioned in annexure – A, Details of buildings in annexure B and other details in annexure C. So far, 23 building structures (big & small) as per Annexure -'B' have been constructed in campus. Plenty of lawns & plants have been developed in this campus. All details of buildings & institutions will be provided by Institute Works Department (IWD), IISER Mohali as per requirement of the agency.

Eligibility Criteria:

- 1 The firm should be certified energy auditor firm. It is compulsory for the firm to be BEE approved (Bureau of Energy Efficiency) otherwise offer will be rejected.
- 2. Contractors/firms should have successfully completed (competition certificate alongwith the detailed work order to be provided), during last 7 years ending last day of the month previous to the one in which the bidding are invited, either three similar works having area not less than 40% (50,075 sqm) or two similar works having area not less than 50% (62,595 sqm) and one similar work having area not less than 80% (1,00,150 sqm)

OR

Either three similar works costing not less than 40% (Rs 2,40,000/-) or two similar works costing not less than 50% (Rs 3,00,000) and one similar work costing not less than 80% (Rs 4,80,000) of the estimated cost/area of the work, of at least one should be in Govt./Semi Govt/ PSU/ Autonomous Body.

Similar work means - "Energy Audit".

- 3. Average annual financial turn over during the last 3 (three) years ending 31st March of the previous year should at least be 50% of the quoted rates.
- 4. Not incurred loss in more than two years during the last five years ending 31st March of the previous year.

Other Terms & Conditions

- a. The Institute reserves the right to reject any or all offers without assigning any reason.
- b. The work/job shall be carried out strictly according to specifications and to the entire satisfaction of the Engineer-in-Charge.
- c. The rates will be excluding all taxes and charges. Taxes will be as per GoI orders from time to time.
- d. Deduction of all taxes and surcharge will be made as per Govt./IISER rules from time to time.
- e. Time limit for Conducting Energy Audit of IISER Mohali campus will be 60 days from the date of issue of work order.
- f. Penalty of 0.5% per week shall be imposed for delay in work.
- g. The Institute may also forfeit the Earnest Money besides taking other action against the firm including its blacklisting. In case of any other breach of contract/agreement. The Institute will be at liberty to levy a compensation upto 10% of the amount of the contract and may also take any other penal action including the black listing. An appeal against these orders shall, however, lie with the Director, IISER Mohali whose decision shall be final

Payment Terms:

- 75% Upon submission of draft report.
- 25% After submission of Final Report alongwith certificate.

The firm will conduct energy audit as per BEE norms covering all the energy consuming equipments/area with emphasis on the following:

- i. Review of electricity bills, contract demand etc. : For the last one year in which possibility will be explored for further reduction of contract demand, improvement of suitable parameters like power factor etc. as per the assessment.
- ii. Electrical system network: which would include detailed study of all the transformers operation of various ratings/capacities, their operational pattern, loading, no load losses, power factor measurements on main distribution networks, scope of improvement if any.
- iii. Electrical motor loading: Study of electrical motors loading of rating 10 Hp and above in terms of percentage loading, current, power etc and thereby suggesting measures of energy saving.
- iv. Illumination: Study of illumination system, Lumens in various areas and suggesting measures for improvement, energy conservation etc.
- v. DG sets: studying operation of various DG sets installed to evaluate average cost of power generation and identify areas where energy saving can be achieved after analyzing the opeartions.
- vi. If required, The firm should also conduct harmonic analysis and monitor of power system, should submit report with all data.

General Conditions:

- 1. The requisite tests necessary for a successful energy audit shall be conducted by the firm which is covered in the scope of audit. The firm will assess & analyze / conduct survey of the institution & submit audit report.
- **2.** Energy audit report will be finalized and handed over to IISER Mohali within 3 months from the date of work order. Audit report to be in hard and soft copy both, with all details.
- **3.** Firm may visit IISER Mohali before quoting to get a clear overview.
