## A) **IMPORTANT NOTES:-**

- I. **This is a domestic Tender according to the DPIIT OM dated 04/06/2022 and subsequent amendments to the order for Public Procurement Preference & PROVISION FOR LOCAL SUPPLIERS TOWARDS PREFERENCE TO MAKE IN INDIA. Bidders should also give details of Locations(s); at which the local value addition is made. Bidders are requested to furnish the declaration regarding local content/locations in Annexure II.**
- II. **Restriction under Rule 144 (xi) of the General Financial Rules (GFRs). 2017 under sub clause 3, in terms of DOE, MoF No. F.18/37/2020-PPD dated: 8<sup>th</sup> February, 2021:**
  - (i) A bidder is permitted to procure raw material, components, sub-assemblies etc. from the vendors from countries which share a land border with India. Such vendors will not be required to be registered with the Competent Authority, as it is not regarded as "sub-contracting".
  - (ii) However, in case a bidder has proposed to supply finished goods procured directly/indirectly from the vendors from the countries sharing land border with India, such vendor will be required to be registered with the Competent Authority- Bidder to fill ANNEXURE-VI to this effect.
- III. The online updated Price BOQ is in INR format. Bids are invited in INR only against domestic tender, in compliance with the conditions specified above under (A) I.

### **C) INSTRUCTIONS:-**

1. The quoting firm(s) have to upload the name of Category and Brand name/Principal Company name (As BOQ/Schedule enclosed) failing which the offer will be summarily rejected.
2. **The firms should be registered with Sales Tax Authorities. A valid PAN /GST Number of the tenderer has to be provided/enclosed/upload with a copy of proof with self attested. PAN and GST Number are required for both Principle Company and Authorised dealer/distributor/channel partner.**
3. **The companies who are unable to provide validity of rates for One Year on the price list need not apply. The Bidder in no condition can revise the rate within the Contract Period.**
4. **The Rate Contract will be valid for a minimum period of One Year.** Institute may consider further extension of one year on existing terms for whole or part of bidders subject to satisfactory performance. The firm and their authorised distributor should provide their e-mail and full correspondence address with contact number. Annual Rate Contract for more than one year will also be considered.
5. There shall be no change in price structure /currency during the contract period except of the Statutory levies which are made applicable by the Govt. through notification/regulations subject to change. Hence, the firms who can give valid price for one year need only apply.
6. While submitting Price list in foreign currency, then the bidder must submit the price list of Principal Company or the price list submitted by bidder must have the endorsement of the Principle company.
7. Prices charged for the stores supplied under Rate Contract should under no event be higher than lowest prices at which the party sells the items of indential description to any other organization or any other platform during the period of contract.
8. If the supplier fails to deliver the material within the delivery period as specified by purchaser may procure such items as deems appropriate for.
9. **The supplier will be liable to the purchaser for any excess costs incurred for procurement of goods or services not delivered in time. The supply of material will have to be completed within 30 days from date of issue of purchase order. The liquidated charges @0.5% per week shall be imposed if supply is made after expiry of delivery period subject to maximum 10% of the total value of goods/contract value.**

10. IISER Mohali also reserves right to test the chemicals and solvents of material for their quality if it so desired.
11. The items, so supplied will have to be of high quality and grade and in the inspection/test if these are found to be of inferior quality, the same are to be replaced by supplier at their cost within the stipulated period, failing which the RC of the firm may be cancelled. Delayed supply/non-compliance of complete order may also lead to cancellation of Contract.
12. **The rates offered should be FOR IISER Mohali. In case of Ex-godown terms the amount of packaging forwarding freight etc. (incomplete) will be borne by the qualified bidder.**
13. No Bill for part payment will normally be entertained. The payment of the bill will be made within 30 days on receipt of the complete goods in satisfactory condition.
14. **Price should be FOR delivery at IISER Mohali, Sector-81 , Mohali. The freight, insurance charges, if any will not be borne by the Institute.** Similarly shortage, pilferage in transit will be sole responsibility of the supplier and the same will be intimated to the supplier on receipt of goods by the purchaser to make good the loss caused on this account. The defective supply will have to be replaced by the supplier within 7 days without freight/transport charge.
15. Discount, taxes and other charges, if any, are to be specified clearly. **Authorization Certificate from the Principal is mandatory for submitting the Rate Contract bid/proposal. The Bid/proposal submitted by authorized stockiest/dealers then authorization to any dealer/distributor from Principle must be enclosed/uploaded.**
16. The principal company authorized any one dealer/firm/supplier in tender will be the final. No request will be considered to change the same and also no request will be accepted to divert the order to some other firms/suppliers during the Rate contract period.
17. The Bidder/Company/Authorised distributor/Authorized dealer/Channel Partner/nominated vendor with whom Government transactions are banned or suspended or blacklisted due to any reasons including corrupt and fraudulent practices adopted by them shall not be eligible to submit the bids. 18. If any Bidder/Company/Authorised distributor/Authorized dealer/Channel Partner/nominated vendor found offering any lower Price/ higher discount than the offered to IISER Mohali, to any other Institute/University, shall be Debarred and Blacklisted automatically by IISER Mohali without any further reference to the said firm (s). **(Annexure-V enclosed)**
19. **CDEC-** As applicable as per GOI Rules.
20. **GST-** As applicable as per GOI Rules.
21. If any dispute arises, Jurisdiction of court will be S.A.S. Nagar (Mohali), Punjab only.
22. All MSME/NSIC/Startup Units shall be considered as per provisions/rules prescribed by Govt of India.

#### **D) SUBMISSION OF TENDER:-**

- I. If the tender opening date happens to be on a holiday or non-working day due to any other valid reason, the tender opening process will be attended on the next working day at same time and place. IISER Mohali will not be responsible for any error like missing of schedule data while downloading by the Bidder.
- III. **The bidder shall upload the tender documents/NIT duly filled in and stamped by the authorized signatory on each and every page along with all necessary Annexures, declaration, information desired as per NIT and Checklist. Tender not submitted/uploaded in the prescribed form and as per the tender terms and conditions shall be liable for rejection. #### LABORATORY ANIMAL FEED (Irradiated)

**I.** **Specifications:** (Detailed chemical composition given below)

1. Moisture should be less than 10%
2. Crude protein should be  $\geq 18\%$
3. Crude fat should be  $\geq 5\%$
4. Crude fiber should be  $\leq 5\%$
5. Tested for Aflatoxin B1, B2, G1, G2 and should be below limit of quantification.
6. Tested for poisonous/heavy metals like mercury, lead, cadmium, selenium, arsenic
7. Should be tested for microbiological contamination with *Vibrio cholerae*, *V. parahaemolyticus*, *S. aureus*, *L. monocytogenes*, *Salmonella*, *E. coli.*, moulds etc.
