The two bid system will be followed for this E- Quotation. In this system the bidder must submit bid on line at **E-Procurement Portal (i.e. <https://eprocure.gov.in/eprocure/app>)** his offer in two covers. "**Cover No. I- Technical Bid along with requisite fee details and all forms under seal and signature of Bidder**" mentioned below and "**Cover No.II - Financial Bid**" respectively.

Cover –II, i.e. Price Bid:

The **Cove I** (Technical Bid) shall consist of following:

- i) **Earnest Money** -The bidder shall furnish as part of its bid, an EMD of **Rs. 1,600/- (Rupees one thousand and six hundred only)**. The EMD is to be submitted through Demand Draft of any Scheduled / Nationalized Bank (drawn in favour of “Registrar, IISER, Mohali”) or MSME certificate should be relevant to the work for which NIT called for.

GENERAL CONDITIONS OF THE RFQ

1. The rates shall be quoted in the enclosed schedule of quantities and duly signed by the contractor.
2. Rates to be inclusive of GST, etc.
3. Rates to remain firm during the duration of work as well as for the extended period, if any. No escalation in rates will be allowed in any circumstances.
4. The contractor shall comply with all statutory requirements in respect of said work.
5. The cleaning shall be carried out as per the direction of Engineer in charge and as per procedure given in BOQ. The water at source after cleaning shall be tested for TDS
6. Quantity can be increase or decrease.
7. Safety of workers will be the sole responsibility of the contractor
8. The time of completion of entire work is four weeks i.e. 28 days to be reckoned from the day of issue of award letter.
9. EMD amounting to Rs.1,600/- in favour of Registrar IISER, Mohali payable at Mohali. (MSME/ NSIC certificate in lieu of EMD should be relevant to the work, for which tender is called will be accepted.
10. Penalty of 0.5% per week shall be imposed for delay in work.
