Micro & MSME/NSIC and Firms registered and the firms registered with concerned Ministries/ Departments, the bidders are exempted from payment of Tender Fee as per GOI notifications/GFR (2017) and Ministry of Finance OM No. F.9/4/2020-PPD dated 12 November 2020.

1.	Supply of Spare/Repairing Unisoku STM Model USM-1300	
	Technical Specification:	
	1. The Scanning Tunneling Microscope supplied by M/s Unisoku Pvt. Ltd. needs repairing for mitigating high liquid helium loss rate due to a leak developed in a super-insulated Liquid Helium Dewar that holds a bottom-loaded superconducting magnet (11 Tesla).	
	2. The vendor will be responsible for providing all the necessary hardware to fix the problem.	
	3. To resolve the issue mentioned in 1, a low-loss Liquid Helium Dewar along with a 11 Tesla superconducting magnet needs to be provided and made adaptable with the existing functional hardware of the Unisoku STM Model USM-1300 and integrated with the STM system at IISER Mohali.	
	 4. All the associated hardware (as in the existing system) including a Helium level gaugeand an appropriate magnet power supply must be provided. 5. The expected consumption rate with the existing He3 insert should be less than 0.6L/h 	
	6. The liquid helium reservoir volume should be preferably greater than 100 litre. The loss rate with and without the STM heat load must be mentioned in the quote. The loss rate (with full STM heat load along with the magnet) should be (preferably) less than 0.75 liter/hr.	
	 The inner wall of the Liquid Helium Dewar should be made of stainless steel. The Liquid Helium Dewar should be equipped with a provision to install a low-vibrationhelium reliquefier siphon, in addition to the standard helium transfer port. This is needed to enable the institute to connect a helium liquefier with the STM system in the future, if needed. 	
	9. The Liquid Helium Dewar and the magnet need to be designed appropriately such that the existing He3 hardware fits inside the magnet and the magnetic field center matches with the position of the sample stage in the Unisoku STM head.	
	10. After the installation of the replacement parts, the vendor will also be responsible for performing a thorough cleaning of the STM unit.	
	11. The vendor will need to demonstrate that the problem has been successfully resolved. Showing that the STM works down to 4.2 K through atomic resolution imaging and spectroscopy on HOPG will be a mandatory requirement.	
	12. The vendor will also provide hands on training to the STM lab members on the operation of the repaired STM system.	
	13. The vendor will give a declaration/undertaking that they will be able to support the full STM system by providing with spare parts and services as and when required, for the next 8 years, on payment basis so that the equipment remains functional for a long time.	
	 14. Warranty: The repair job must have a warranty of one year from the date of performance test after repair. 15. AMC: A separate quote for an annual maintenance contract (with all parts) for the whole STM system should also be provided. Bidder should quote in BOQ / Financial Bid per year rate in the basic column no. 7. 	

A) IMPORTANT NOTES:-

- I. Relaxation on Global Tender Enquiry (GTE) in terms of Sub-Clause 2 on Procurement of Spares of Equipment/Plants and Machinery from OEM/OES/Original Part Manufacturers (OPMs) issued by Ministry of Finance, DOE, Procurement Policy Division GOI vide Circular No. F.12/17/2019-PPD dated 29 October 2020.
- II. The online updated Price BOQ is in INR format. If bidder want to quote other than INR please specify the quoted currency in the Technical Bid/Part and fill the amount in same updated BOQ. The value will be treated as INR or quoted currency
- III. Please bifurcate the price on shipping terms i.e. Ex-works -> FCA/FOB -> CIP/CIF in price BOQ and specify the same in technical bid without price. Value will be assumed as INR or foreign currency, as per details furnished in technical bid.
- IV. <u>If quoted in foreign currency, kindly clearly specify the terms of delivery/country of origin/bank details with swift code/weight/size/dimension of shipment.</u>
- V. Restriction under Rule 144 (xi) of the General Financial Rules (GFRs). 2017 under sub clause 3. in terms of DOE. MoF No. F.18/37/2020-PPD dated: 8th February. 2021:
 - (i) A bidder is permitted to procure raw material, components, sub-assemblies etc. from the vendors from countries which shares a land border with India. Such vendors will not be required to be registered with the Competent Authority, as it is not regarded as "sub-contracting".

B) **SUBMISSION OF TENDER**

- I. Tenders/ bids shall be accepted only through online mode and no manual submission of the same shall be entertained except tender fee and Annexure I (Bid Securing Declaration Form). Late tenders will not be accepted.
- II. The online bids shall be opened at the office of the Assistant Registrar (S&P), IISER Mohali, on above given date and time. If the tender opening date happens to be on a holiday or non-working day due to any other valid reason, the tender opening process will be attended on the next working day at same time and place. IISER Mohali will not be responsible for any error like missing of schedule data while downloading by the Bidder.
- III. The bidder shall upload the tender documents/NIT duly filled in and stamped by the authorized signatory on each and every page along with all necessary Annexures as per NIT. Tender not submitted/uploaded in the prescribed form and as per the tender terms and conditions shall be liable for rejection.

- IV. The bidder shall upload scanned copy of the PAN Card, GST number duly signed and stamped. Also bidders applying against "MSME/NSIC Certificate" issued by appropriate Authority, should ensure that the certificate attached is relevant to the area of service/supply. For example, If the tender is for "supply & installation of Desktop" the certificate should be issued for activity/area of "Computer supply and services activities etc" otherwise bid will be REJECTED without notice.
- V. E-procurement system ensures locking on the scheduled date and time. The system will not accept any bid after the scheduled date and time of submission of bid.

C) INSTRUCTIONS

- 1. The Online bids should be submitted directly by the original manufacturer/supplier, If quotation is submitted/filled by any representative/agent/dealer then they must upload a authority certificate from the principal company for quoting the price otherwise such quotation will be rejected.
- 2. The quantity mentioned in this inquiry is and shall be deemed to be only approximate and will not in any manner be binding on the Institute. Before the deadline for submission of the online bid, IISER Mohali reserves the right to modify the tender document terms and conditions. Such amendment/modification will be notified on website against said tender ID.
- 3. The rates offered should be FOR Chandigarh/Mohali in case of firms situated outside Chandigarh/Mohali, and free delivery at the Institute premises in case of local firms. Conditional tenders will be summarily rejected.
- 4. In case of Ex-godown terms the amount of packaging forwarding freight etc. should clearly be indicated by percentage or lump sum amount in the BOQ. Institute has policy not to make any advance payments towards any purchase. However, Letter of credit (FLC) can be opened upto maximum of 90% for the shipment value, in case of Global Tender Enquiry (GTE's) and balance 10% through wire transfer subject to fulfilling the conditions of purchase order (on INCO-TERMS CIP/CIF etc.).
- 5. Custom Duty, applicable as per GOI Norms.
- 6. **GST**, applicable as per GOI Norms.

- 7. Bidder/s quoting in currency other than Indian Rupee (INR) should explicitly mention the currency (USD, Euro, JPY, CHF and Pound-Sterling etc.) in which tender quoted wherever applicable in <u>Technical Bid</u> along the tender documents.
- 8. The items, so supplied will have to be of high quality and grade and in the inspection/test if these are found to be of inferior quality, the same are to be replaced by supplier at their cost within the stipulated period, failing which the EMD of the firm will be forfeit. Delayed supply/non-compliance of complete order may also lead to cancellation of order, if technically found suitable and L-1.
- 9. The delivery period should be specifically stated(FOR CIP/CIF OR Ex-works). Earlier delivery will be preferred.
- 10. The firms are requested to provide/upload detailed description and specifications together with the detailed drawings, printed leaflets & literature of the article quoted and also should enclose <u>Technical Compliance Sheet.</u> The name of the manufactures and country of manufacture should also invariably be stated. In the absence of these particulars and documents, the quotation is liable for rejection. Tenders not accompanied by detailed information as required, are liable to be rejected.
- 11. If any information furnished by the bidder is, at any stage found to be incorrect, false or fabricated, the Institute/purchaser shall have the absolute right to forfeit E.M.D. and security deposits, in addition to cancellation of contract, forfeiting the warranty/performance Guarantees and other action in accordance with law, such as black-listing, risk & cost etc.
