- 1. Inquiry will be sent by UPC/Courier/Speed Post and IISER Mohali will not be liable for any kind of Postal delay.
- 2. The Quotation should be addressed to the Director IISER Mohali invariably giving on the envelop Reference No. with date and Due date with time.
- 3. One time importers from China with custom made specifications are highly discouraged.
- 4. The quantity mentioned in this inquiry is and shall be deemed to be only approximate and will not in any manner be binding on the Institute.
- 5. Firms will quote separately for each article.
- 6. The rates offered should be FOR Chandigarh/Mohali in case of firms situated outside Chandigarh/Mohali, and free delivery at the Institute premises in case of local firms. Supply outside India please mention the FOB/FCA price clearly.
- 7. In case of Ex-godown terms the amount of packaging forwarding freight etc should clearly be indicated by percentage or lump sum amount. Institute has policy not to make any advance payment towards any purchase, Letter of credit can be open if required.
- 8. In case of foreign consignment CIF/FOB should be mention clearly. THE INSTITUTE IS EXEMPTED FROM EXCISE AND CUSTOM DUTY.

Specification for: Mill technology based cryogenic pulverizer to grind plant and yeast cells

- 1. Cryogenic grinding capable of disrupting and homogenization of biological material for isolating proteins, nucleic acids, ribosomes from plant and yeast cells. Should have proven publication record for small volume sample isolation from plant and yeast cells (20 ml or less).
- 2. Instrument must be compatible and equipped to grind liquid nitrogen frozen cell sample / dry sample / wet sample with all accessories.
- 3. Grinding Jars with screw-top lid for 10 ml, 25 ml volume with gasket (or similar for cryogenic pulverization of plant/ yeast samples). Two jars should be provided in each category and to hold sample gaskets separately. Four adapter racks for 10 reaction vials of 1.5 & 2 ml, made up of PTFE.
- 4. Compatible grinding balls in stainless steel (sizes 3mm, 5mm) and glass beads of 0.25-0.50 to 0.50-0.75 mm (500gm).
- 5. Self-centering clamping device with two stations to process samples simultaneously.
- 6. Vibrational frequency should be in the range of 3 to 30 (±5) MHz (180 to 1800 per minute). Programmable grinding time to range should be between 10s and 99 minutes. Should be self-contained with all accessories required for the said isolation in points 1& 2. System should be able to reduce materials to 6 micrometer or less and should have noise value below 70 dB (A).
- 7. Should be quoted with 3 years warranty and prices of each item in the quote should be given in item wise manner including the warranty. Please give at least three purchase order copies of the supplied item to reputed Govt. organization to support the price claim in last three years. All the quoted items should have cat. no. in the quote and must be supported with international bench mark in the form of published original brochures.
- 8. If a bidder fail to provide any of the information mentioned above, his or her quote will be rejected straightway without any communication. If a bidder found concealing information related to origin, compatibility and suitability as well as past purchase orders related to the product, then we will reject his bid immediately.
- 9. Justify the quoted material with appropriate original catalogue citing the cat. No. in the order of requirement.
