	1.	Required vacuum concentrator should concentrate samples like DNA, RNA and Proteins etc. with precise temperature, rpm and vacuum control through	
	2.	Concentrator chamber should be acid resistant and Teflon coated.	
	3.	The rotor to hold 40 or above for 1.5/2 ml tubes should be supplied along with the system and other size rotors should also be quoted as optional accessories.	
	4.	Temperature range should be at least ambient to 80°C or with lower limit of 5°C.	
	5.	Concentration of sample should be fully programmable for temperature, run time and vacuum level.	
	6.	Concentrator rpm should be minimum 1500 or adjustable up to 2000 rpm.	
	7.	Concentrator should be supplied with acid resistant cold trap made of 316 grade seamless stainless steel with external cooling coil with digital alpha numeric temperature display.	
	8.	Cold trap should attain minimum temperature of -50°C or below and should be of at least 4 liter capacity.	
	9.	System should be supplied complete along with chemical resistant vacuum pump of at least 37 liters/min displacement capacity and should attain minimum of 9 mbar ultimate vacuum.	
	10.	Vendor should supply a cart suitable to stably hold and operate the system.	
	11.	Complete concentrator should be upgradable to function as a lyophilizer with minimum 4 to 8 tree type manifold, and accessories for the same should also be quoted.	
	12.	All tubing and connectors should be included as the part of concentrator.	
	13.	All items should come from the same principle company.	
	14.	Machine manufacture should compliant to CE, DS/EN and ISO certification standards and certificates should be enclosed.	
	15.	The vendor should submit case specific authorization letter and certificate from the manufacturer for supply of spare parts for at least 10 years of purchase, if quoted by the distributor. If manufacturer is quoting directly, the company should submit a certificate committing to make available the spare parts for at least 10 years from purchase on their letterhead.	
	16.	The vendor should give a warranty of at least 3 years from the date of installation of the system.

- 7. In case of Ex-godown terms the amount of packaging forwarding freight etc should clearly be indicated by percentage or lump sum amount. Institute has policy not to make any advance payment towards any purchase, Letter of credit can be opened if required.
