1.	Table: Table top: pre laminated post formed MDF board, 18mm thick, 650mm x 910mm. Table top should be at a height of 750mm from the ground. Frame: CRCA Pipe, 18G, 25X50 mm and 25x25 mm as the support structure. Reading lamp (LED, 5W), permanently mounted on the table in a raised hood. Switch for the lamp should be at the base of the hood. The lamp should be mounted 400mm above the table top. In built plug point to support up to 2A current at 220V AC. Plug to be located at the base of the hood.	30
2.	Chairs: Seat/Backshell: The sheet backshell is made up to 1.2 cm thick hot-pressed plywood laminate with natural veener in shade of teak. Back size: 40.5cm (W) x 40.5cm (H), Seat size: 43cm (H) x 39cm (W). Tabular understructure: The understructure is made up of dia 1.6cm x 14 G thickness and black coated. It is to be fitted with black injection ferrule and support features.	40

- 5. The rates offered should be FOR Chandigarh/Mohali, in case of firms situated outside Chandigarh/Mohali, and free delivery at the Institute premises in case of local firms. Suppliers outside India may please mention the FOB/FCA price clearly.
- 6. In case of Ex-godown terms the amount of packaging forwarding freight etc. should clearly be indicated by percentage or lump sum amount. Institute has policy not to make any advance payment towards any purchase, Letter of credit can be opened if required.
