01	<b>UPS 10 KVA - Specification</b> <ol style="list-style-type: none"><li>1. The system should be of any one of the following make: Emerson, Gutor, Liebert, Merlin Gerin or Mitsubishi.</li><li>2. Input side power factor should be unity with input voltage range 291-551V and output voltage 230VAC±1% in single phase.</li><li>3. External SMF batteries of 26AH/12V (26 numbers) should be provided within a close cabinet with 4 fans and wheels.</li><li>4. With type true on-line double conversion 3 phase input and 1 phase output.</li><li>5. The output should have inbuilt isolation between the UPS and connected load with inbuilt isolation transformer with input-output cable.</li><li>6.
