ESSENTIAL REQUIREMENTS:	
1. The service provider should be registered firm and authorize to run above service	
2. The agency to have local office in Chandigarh/Mohali/Panchkula.	
3. The Ambulance should be provided with advance basic amenities/first aid.	
4. The ambulance will be used to transfer patients.	
5. The service required is 24 x 7.	
6. In case of vehicle breakdown/servicing etc a replacement vehicle having similar provisions will have to provide.	
7. The staffs attached with ambulance is required with mobile phones for better communication.	
9. The driver attached to the vehicle should be well mannered and in a clean clothing.	
10. The vehicle should not be more than two years old (having registration on after 2015). The condition of the vehicle should be good well maintained.	
12. The firm shall have to provide (keep along with vehicle) extra wheels, proper tools and	
tackles, one torch, first aid box, fire extinguishers and any other item as required by law.	
13. The monthly hiring charges payable for the Ambulance shall be for 1000 kilometers in any calendar month. Beyond 1000 kilometers the Contractor will be paid on a per kilometer basis. The institute shall not be responsible for any loss or damage for the vehicle and person engaged by the agency.	
14. At least 1 years' experience of running an Ambulance with any Govt./PSU/Hospitals/NGO or any reputed organization	
15. Initially the contract will be of one year from the date of commencement of contract subject to satisfactory performance extendable upto 3 years. In such matters, the decision of Director, IISER Mohali will be final.
