- The period of Warranty will be at least of 1 year and there will be facilities for after sales services for 3 years.
- IISER Mohali also reserves right to test the quality of material if so desired.
- Payment will be made on the Bill basis only. No advance payment will be made.
- Price will be for delivery at IISER Mohali, Sec-81, SAS Nagar Mohali.
- Inquiry will be sent by UPC/Courier/Speed Post/By Hand and IISER will not be liable for any kind of Postal delay.
- The quotation should be addressed to the Director invariably giving on the envelop Reference No. with date and Due date with time.
- The quotation should be enclosed in a sealed envelop.
- The quantity mentioned in this inquiry is and shall be deemed to be only approximate and will not in any manner be binding on the Institute.
- Firms will quote separately for each article.
- The rates offered should be FOR Chandigarh in case of firms situated outside Chandigarh and free delivery at the Institute premises in case of local firms.
- In case of Ex-godown terms the amount of packaging forwarding freight etc should clearly be indicated by percentage or lump sum amount. Current rate of sales Tax/VAT must be mentioned. THE INSTITUTE IS EXEMPTED FROM EXCISE AND CUSTOM DUTY.
