Sealed quotes(separately for each shops) are invited on plain paper for the allotment of following four shops in IISER, Mohali Campus, Sector 81, Knowledge City, SAS Nagar for a period of 1 year on lease basis:

- . Shop for Grocery & Provisions as well as daily needs and also perishables like Vegetables/Fruits/Milk/Bread.
- . Shop for Stationary/Books/Xeroxing/General items including OTC drugs/mobile recharge etc.
- . Shop for Unisex Saloon.
- . Shop for an eatery that could supply Juices & Shakes, Coffee, Bakery Products etc.

Rs. 4000/- p.m. has been fixed as reserved lease money. Interested person(s)/agencies may submit 'Sealed quotes along with the write up for details as mentioned below from point No 1 to 4 addressed to the Registrar, IISER Mohali along with Demand Draft of Rs. 500/- as earnest money drawn on any scheduled Bank, payable in favour of Registrar, IISER Mohali latest by 11.07.2011;

- 1) Past experience in running the shops. In case the bidder has prior experience, the details may be provided that include the name of the shop, address, and since when he is running the shop.
- 2) How the bidder intends to maintain a clean and hygienic environment inside and around the shops.
- 3) To indicate the kind of quality they would maintain in respect of the items being sold, both perishable, and non-perishable.
- 4) No. of persons who will be deployed in running the shops.

The bidders not providing the details as mentioned above, along with their offer, are liable to be rejected.

The price bids/ quotes shall be opened by the constituted committee on **18.07.2011 at 3.00 p.m.** in **Central Analytical Facility (CAF) building, IISER Mohali.** The successful bidder will have to deposit a sum of **Rs.8000/- (Rs. Eight Thousand only)** as refundable security immediately on the allotment, but before taking possession.
